



#### GENERAL PROVISIONS LOCAL LAW 2012

- describe when permits or approvals are required for road reserve works, car parking, roadside maintenance, traffic controls and planting of street trees.

## FISHERIES (CENTRAL ABALONE ZONE CLOSURE) NOTICE 2016

**1. Title**

This Notice may be cited as the Fisheries (Central Abalone Zone Closure) Notice 2016.

**2. Objectives**

The objective of this Notice is to address sustainability concerns for Victorian Central Abalone Zone abalone stocks and related management issues by closing specified marine waters to commercial abalone harvest.

**3. Authorising provision**

This Notice is made under sections 67 and 152 of the Act.

**4. Commencement**

This Notice comes into operation on the day it is published in the Victoria Government Gazette.

**5. Definitions**

In this Fisheries Notice –

**abalone** means blacklip and greenlip abalone and includes all other species, forms, races and hybrids of abalone.

**closed waters** means the marine waters within a spatial management unit for which a determination has been made under clause 7 (1) of this Fisheries Notice.

**Executive Director** means the Executive Director Regulation and Compliance (Fisheries) employed in the Department of Economic Development, Jobs, Transport and Resources.

**spatial management unit** means each area of Victorian marine waters between the coordinates specified in Column 2 of the Table in the Schedule under the name specified in Column 1 of the Table corresponding to that area.

**upper limit** for the spatial management unit specified in Column 1 of the Table means the amount of abalone specified in Column 3 of the Table corresponding to that spatial management unit.

**6. Determination that catch target exceeded**

(1) The Executive Director may determine that the total amount of abalone taken under Abalone Fishery (Central Zone) Access Licences from a spatial management unit has exceeded the upper limit.

(2) Without limiting the generality of sub-clause (1), a determination may:

- (a) specify one or more spatial management units;
- (b) specify that it comes into effect on a particular date and time; and
- (c) be varied or revoked at any time.

(3) The Executive Director must ensure that a copy of the determination is sent to each holder of an Abalone Fishery (Central Zone) Access Licence as soon as possible after it is made.

**7. Closed waters**

- (1) For the purposes of section 67 of the Act –
- (a) the taking of abalone from closed waters; or
  - (b) the possession of abalone in, on or next to closed waters –
- by the holder of an access licence, or a person acting or purporting to act under an access licence, is prohibited.

**Note:** Failure to comply with this prohibition is an offence under section 67 of the **Fisheries Act 1995**. A maximum penalty of 100 penalty units and/or six months imprisonment applies.

- (2) Sub-clause (1)(b) does not apply to a person possessing abalone on-board a boat under way and travelling by the most direct route to reach a point of landing or specified open waters for the purpose of commercial abalone diving.
- (3) In addition to the penalty under section 67(3), a person who contravenes the prohibition in sub-clause (1) is liable to a further penalty –
- (a) in the case of a first offence, a penalty not exceeding 0.5 of a penalty unit for each abalone taken or possessed;
  - (b) in the case of a subsequent offence, a penalty not exceeding 1 penalty unit for each abalone taken or possessed.

**FISHERIES (EASTERN ABALONE ZONE CLOSURE) NOTICE 2016****1. Title**

This Notice may be cited as the Fisheries (Eastern Abalone Zone Closure) Notice 2016.

**2. Objectives**

The objective of this Notice is to address sustainability concerns for Victorian Eastern Abalone Zone abalone stocks and related management issues by closing specified marine waters to commercial abalone harvest.

**3. Authorising provision**

This Notice is made under sections 67 and 152 of the Act.

**4. Commencement**

This Notice comes into operation on the day it is published in the Victoria Government Gazette.

**5. Definitions**

In this Fisheries Notice –

**abalone** means blacklip and greenlip abalone and includes all other species, forms, races and hybrids of abalone.

**closed waters** means the marine waters within a spatial management unit for which a determination has been made under clause 7 (1) of this Fisheries Notice.

**Executive Director** means the Executive Director Regulation and Compliance (Fisheries) employed in the Department of Economic Development, Jobs, Transport and Resources.

**spatial management unit** means each area of Victorian marine waters between the coordinates specified in Column 2 of the Table in the Schedule under the name specified in Column 1 of the Table corresponding to that area.

**upper limit** for the spatial management unit specified in Column 1 of the Table means the amount of abalone specified in Column 3 of the Table corresponding to that spatial management unit.

#### 6. **Determination that catch target exceeded**

- (1) The Executive Director may determine that the total amount of abalone taken under Abalone Fishery (Eastern Zone) Access Licences from a spatial management unit has exceeded the upper limit.
- (2) Without limiting the generality of sub-clause (1), a determination may:
  - (a) specify one or more spatial management units;
  - (b) specify that it comes into effect on a particular date and time; and
  - (c) be varied or revoked at any time.
- (3) The Executive Director must ensure that a copy of the determination is sent to each holder of an Abalone Fishery (Eastern Zone) Access Licence as soon as possible after it is made.

#### 7. **Closed waters**

- (1) For the purposes of section 67 of the Act –
  - (a) the taking of abalone from closed waters; or
  - (b) the possession of abalone in, on or next to closed waters –by the holder of an access licence, or a person acting or purporting to act under an access licence, is prohibited.

**Note:** Failure to comply with this prohibition is an offence under section 67 of the **Fisheries Act 1995**. A maximum penalty of 100 penalty units and/or six months imprisonment applies.

- (2) Sub-clause (1)(b) does not apply to a person possessing abalone on-board a boat under way and travelling by the most direct route to reach a point of landing or specified open waters for the purpose of commercial abalone diving.
- (3) In addition to the penalty under section 67(3), a person who contravenes the prohibition in sub-clause (1) is liable to a further penalty –
  - (a) in the case of a first offence, a penalty not exceeding 0.5 of a penalty unit for each abalone taken or possessed;
  - (b) in the case of a subsequent offence, a penalty not exceeding 1 penalty unit for each abalone taken or possessed.
