#### Marine Safety Act 2010 Section 259

#### ADMINISTRATIVE AMENDMENTS TO WATERWAY RULES

- I, Peter William Corcoran, Director Maritime Safety (as delegate of the Director, Transport Safety), make the following administrative amendments to the notice made under section 15(2) of the **Marine Act 1988** and published in the Victoria Government Gazette No. S 221, Thursday 28 June 2012. These amendments are made under the general power of the Director, Transport Safety in section 259 of the **Marine Safety Act 2010** as necessary or convenient to make the consequential waterway rule below.
- 1. After Clause 25 in the 'Index to Schedules':
  - (a) after 'Tamboon Inlet and all the navigable waters with an opening to that inlet Department of Sustainability and Environment 108', and
  - (b) before 'Taylors Lake (Horsham) Grampians Wimmera Mallee Water 143'
    - insert under the heading 'Waters' the words 'Taylors Creek', and
    - under the heading 'Waterway Manager' insert the words 'Shire of Campaspe', and
    - under the heading 'Sch' insert the number '19'.

### Marine Safety Act 2010

Section 185

#### CONSEQUENTIAL RULE

I, Peter Corcoran, Director Maritime Safety (as delegate of the Director, Transport Safety), make the following consequential rule under section 185 of the **Marine Safety Act 2010** which is consequential to the making of the waterway rule for the Gunbower Creek as published in the Government Gazette S279 Wednesday 23 September 2015.

In Schedule 19 of the notice made under section 15(2) of the **Marine Act 1988** and published in the Victoria Government Gazette No. S 221, Thursday 28 June 2012, insert the following;

#### **SCHEDULE 19**

#### Waters - Taylors Creek

Waterway Manager - Shire of Campaspe

- 19.1. Areas prohibited to vessels for the purposes of Clause 9.
  - The following waters of Gunbower Creek, the boundaries of which are marked by beacons (54, 55, 56, and 57) on the shore:
  - (a) comprising the township of Gunbower water supply area enclosed by an imaginary line along the western banks of Gunbower Creek at the junction with Taylors Creek and another imaginary line across the waterway of Taylors Creek being 100 metres south-west of the Murray Valley Highway Reserve and parallel to that reserve are prohibited to vessels.
