OCCUPATIONAL HEALTH AND SAFETY REGULATIONS 2007

Notice of Variation to Exemption Published 18 February 2016

By written notice published in the Government Gazette (Gazette Number G7 dated 18 February 2016) the Victorian WorkCover Authority (the Authority) granted an exemption to non-Australian residents employed or engaged by Formula One Management Ltd or a Formula One Racing Team to handle freight for the Australian Formula One Grand Prix held at Albert Park Grand Prix Circuit from regulation 3.6.2 of the Occupational Health and Safety Regulations 2007 (the Exemption) in the terms set out in that notice.

The Exemption includes a condition (condition 3) that the exemption is limited to two international operators per racing team and two international operators who are directly employed by Formula One Management Ltd. The Authority has been advised that Formula One Management Ltd has two subsidiary operators, Formula One Management Cargo and DHL, who also undertake forklift operations at the Australian Formula One Grand Prix. The Authority has also been advised that more than two international operators are required to enable Formula One Management Ltd and its subsidiaries to fully carry out their operations at the Australian Grand Prix.

Accordingly, condition 3 of the Exemption is removed to allow the Exemption to apply to more than two international operators at a time.

All other conditions of the Exemption remain the same and must be complied with.

Regulation 7.2.14 provides that the Authority may vary an exemption at any time. In the case of an exemption applying to a class of persons the exemption may be varied by placing a notice in the Government Gazette setting out the variation and reason(s) for it. The reason this Exemption is varied is to allow for more than two international operators to undertake forklift operations at the Australian Formula One Grand Prix at a time.

The variation to this Exemption starts from the date of publication of this notice in the Government Gazette.
