## Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES  
IN FERNSHAW FOR THE NISSAN NAVARA TV COMMERCIAL FILM SHOOT  
ON 30 AND 31 MARCH, 1 APRIL AND 4 APRIL 2016

**1 Purpose**

The purpose of this Declaration is to exempt participants in the Nissan Navara TV Commercial Film Shoot from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 on 30 March, 31 March, 1 April and 4 April 2016.

**2 Authorising provision**

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

**3 Commencement**

This notice takes effect on 30 March 2016.

**4 Expiry**

This notice expires at 3.30 pm on 4 April 2016.

**5 Definitions**

In this notice, unless the context or subject matter otherwise requires –

- a) ‘Event’ means the Nissan Navara TV Commercial Film Shoot, to be held on 30 March, 31 March, 1 April or 4 April 2016; and
- b) ‘Participants’ means participants in the Event, including officers, members and authorised agents of Exit Films Pty Ltd, whose presence is reasonably required to ensure the safe conduct of the Event.

**6 Declaration**

I, John Cunningham, as delegate of the Minister for Roads and Road Safety, under section 99B(4) of the **Road Safety Act 1986**, declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in Column 1 of Table 2 on the date and during the period specified in Column 2 of Table 2, provided there is full compliance with any conditions imposed by VicRoads and the municipal council.
