Road Management Act 2004

ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares or revokes the roads described in Schedule A and on the plans attached. VicRoads also authorises the access points described in Schedule B and on the plans attached.

The effects of these Road Declarations on road names are described in Table 1.

SCHEDULE A

FREEWAY

- a) Those parts of Goulburn Valley Freeway identified by hatching on the plans numbered GP22844, GP21776, GP21846, GP21848, GP21850, GP21852, GP21855, GP21858, GP22847 and GP21742 are declared or revoked as described in the legend in the said plans.

ARTERIAL ROAD

- b) Those parts of Avenel–Nagambie Road identified by hatching on the plan numbered GP22845 are declared as described in the legend in the said plan.
- c) Those parts of Nagambie Main Road identified by hatching or heavy solid line on the plans numbered GP22845, GP336AR and GP22847A are declared or renamed as described in the legend in the said plans.

MUNICIPAL ROAD

- d) Those parts of Mitchellstown Road, Newnhams Road, Tabilk–Monea Road, Habel Road, Plain Road and Nagambie–Locksley Road identified by hatching on the plans numbered GP22844A and GP22846 are declared as described in the legend in the said plans.
- e) Those parts of Hayshed Road, Kirwans Bridge Road, Peppercorn Road and Grimwade Road identified by hatching on the plans numbered GP22847B and GP21742A are declared as described in the legend in the said plans.
