- 11/2016     (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
              (2) If a provision of this Act does not come into operation before 1 August 2016, it comes into operation on that day.
- 12/2016     (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
              (2) If a provision of this Act does not come into operation before 1 December 2016, it comes into operation on that day.
- 13/2016     (1) This Act, except Parts 2 and 6 and items 1 and 5 of Schedule 1, comes into operation on the day after the day on which it receives the Royal Assent.  
              (2) Subject to subsection (4), Part 2 and item 1 of Schedule 1 come into operation on a day to be proclaimed.  
              (3) Subject to subsection (4), Part 6 and item 5 of Schedule 1 come into operation on a day to be proclaimed.  
              (4) If a provision referred to in subsection (2) or (3) does not come into operation before 1 September 2016, it comes into operation on that day.
