## **Marine Safety Act 2010** Section 211(1)(b)

### NOTICE CONTROLLING NAVIGATION IN THE VICINITY OF WORKS

Parks Victoria, as the declared waterway manager for the waters of the local port of Port Phillip under the **Marine Safety Act 2010** (Act), makes the following notice under section 211(1)(b) of the Act.

For the purposes of the works activity proposed by Australian Project Solutions Pty Ltd for construction of a new eastern rock breakwater and the extension and construction of the northern breakwater as part of the Portarlington Safe Harbour Project, the navigation and other movement of vessels is prohibited in the waters as detailed below, excluding vessels involved directly in the work and Parks Victoria vessels.

#### **Exclusion Zone 1 & 2 – 11 April 2016 to 31 October 2016**

The Waters surrounding the new eastern breakwater extending from shore and then extending north and west encompassing the new northern breakwater as it is constructed, as delineated by yellow special marks with yellow lights (Fl.Y.5s).

#### **Exclusion Zone 3 – 1 November 2016 to 28 February 2017**

The waters surrounding the entire eastern breakwater and the entire northern breakwater, as delineated by yellow special marks with yellow lights (Fl.Y.5s).

The dates and configuration of the exclusion zones may be subject to amendments. Any amendments made will be published in a Notice to Mariners and on the Parks Victoria website.

This notice has effect for the duration of the works from 7.00 am on 11 April 2016 to 5.00 pm on 28 February 2017.
