## Wildlife Act 1975

### WILDLIFE (PROHIBITION OF GAME HUNTING) NOTICE

I, Jaala Pulford, Minister for Agriculture and I, Lisa Neville, Minister for Environment, Climate Change and Water, make the following Notice:

**1. Objective**

The objective of this Notice is to prohibit absolutely the taking, destroying or hunting in Victoria of specified indigenous game birds (waterfowl) in specified areas during specified periods.

**2. Authorising provision**

This Notice is made under section 86(1) of the **Wildlife Act 1975**.

**3. Commencement**

This Notice takes effect from 17 April 2016.

**4. Specified taxa of indigenous game birds**

For the purposes of this Notice, the species listed in the table are specified indigenous game birds (waterfowl):

Common Name	Scientific Name
Chestnut Teal	<i>Anas castanea</i>
Grey Teal	<i>Anas gracilis</i>
Pacific Black Duck	<i>Anas superciliosa</i>
Hardhead (White-eyed) Duck	<i>Aythya australis</i>
Australian Wood Duck (Maned Duck)	<i>Chenonetta jubata</i>
Pink-eared Duck	<i>Malacorhynchus membranaceus</i>
Australian Shelduck (Mountain Duck)	<i>Tadorna tadornoides</i>

**5. Specified areas for clause 6**

Each area described in the table below is specified for the purposes of clause 6 of this Notice.

Area Name	Location
Johnson Swamp State Game Reserve	The whole of Johnson Swamp State Game Reserve near the city of Kerang located in the Shire of Gannawarra.

**6. Hunting of game duck prohibited**

The taking, destroying or hunting of any specified indigenous game birds (waterfowl) is prohibited in any of the areas specified in clause 5 from 17 April 2016 until 13 June 2016.

**7. Contravention of Notice**

A person must not contravene any part of this Notice.

Penalty: 25 penalty units.
