19/2016 **Victoria Police Amendment (Merit-based Transfer) Act 2016**

- 15/2016 (1) This Act comes into operation on a day or days to be proclaimed.
 (2) If a provision of this Act does not come into operation before 1 July 2017, it comes into operation on that day.
- 16/2016 (1) Subject to subsections (2), (3) and (4), this Act comes into operation on a day or days to be proclaimed.
 (2) If a provision of this Act (other than Part 12) does not come into operation before 1 July 2017, it comes into operation on that day.
 (3) If a provision of Division 1 of Part 12 does not come into operation before 1 June 2017, it comes into operation on that day.
 (4) If Division 2 of Part 12 does not come into operation before 1 June 2018, it comes into operation on that day.
- 17/2016 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
 (2) If a provision of this Act does not come into operation before 1 August 2017, it comes into operation on that day.
- 18/2016 (1) Subject to subsections (2) and (3), this Act comes into operation on the day after the day on which it receives the Royal Assent.
 (2) Sections 4 and 5 are taken to have commenced on 20 November 2013.
 (3) Section 6 is taken to have commenced on 16 October 2013.
- 19/2016 (1) This Act comes into operation on the day after the day on which it receives the Royal Assent.
