	(2)	(2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.			
	(3)	If a provision referred to in subsection (2) does not come into operation before 1 July 2017, it comes into operation on that day.			
28/2016	(1)	This Part, Division 1 of Part 4 and Parts 5 and 6 come into operation on the day after the day on which this Act receives the Royal Assent.			
	(2)	Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.			
	(3)	If a provision referred to in subsection (2) does not come into operation before 6 February 2017, it comes into operation on that day.			
29/2016	(1)	This Act, except Divisions 1, 2, 3 and 4 of Part 3, and Part 4, comes into operation on the day after the day on which it receives the Royal Assent.			
	(2)	Division 4 of Part 3 comes into operation on the day on which section 240(1) of the Fines Reform Act 2014 comes into operation.			
	(3)	Subject to subsections (4) and (5), Divisions 1, 2 and 3 of Part 3, and Part 4, come into operation on a day or days to be proclaimed.			
	(4)	If a provision of Division 1, 2 or 3 of Part 3, or Part 4 (except sections 107(2), 109(2) and Division 2), does not come into operation before 1 July 2017, it comes into operation on that day.			
	(5)	If section 107(2) or 109(2) or a provision of Division 2 of Part 4 does not come			

into operation before 31 December 2017, it comes into operation on that day.

- 30/2016 (1) This Part comes into operation on the day after the day on which this Act receives the Royal Assent.
 - (2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
 - (3) If a provision of this Act does not come into operation before 10 December 2016, it comes into operation on that day.

31/2016

- (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 1 April 2017, it comes into operation on that day.

32/2016

- (1) This Act, except Part 3, comes into operation on the day after the day on which it receives the Royal Assent.
- (2) Subject to subsection (3), Part 3 comes into operation on a day or days to be proclaimed.
- (3) If a provision referred to in subsection (2) does not come into operation before 1 March 2017, it comes into operation on that day.
