Notice of Approval of Amendment Amendment GC54

The Minister for Planning has approved Amendment GC54 to the Maribyrnong, Melbourne, Port of Melbourne and Port Phillip Planning Schemes.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment consolidates the planning controls applying to the land and water subject to the Port of Melbourne lease transaction to ensure a coordinated and consistent planning framework for the port, and ensure consistent management of State-side planning matters under a single responsible authority.

BRIMBANK PLANNING SCHEME

Notice of Approval of Amendment Amendment C120

The Minister for Planning has approved Amendment C120 to the Brimbank Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment applies zones and overlays to land formerly owned by the Commonwealth Department of Defence at 26S Glenbrook Avenue and 147A Cairnlea Drive, Cairnlea, which was previously not affected by state planning controls. Specifically, the Amendment:

- zones part of the land to the General Residential Zone Schedule 1;
- zones part of the land to the Commercial 2 Zone;
- zones part of the land to the Public Park and Recreation Zone;
- zones part of the land to the Public Use Zone Schedule 7;
- applies the Development Plan Overlay Schedule 4 to the land;
- applies the Environmental Audit Overlay to the land.
