## Electricity Industry Act 2000

### MINISTERIAL ORDER UNDER SECTION 35(3B)

I, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change and Minister responsible for administering the **Electricity Industry Act 2000** (the Act), specify pursuant to section 35(3B)(a) of the Act, the following dates on which a licensee may publish a notice under section 35(3) of the Act.

**1. Commencement**

This Order commences on the date that it is published in the Government Gazette.

**2. Dates on which a notice varying licensee standing offers must be published**

If, during the period from the date of commencement of this Order until the expiry date of this Order, a licensee proposes to publish a notice under section 35(3) of the Act, varying the tariffs determined by the licensee and published in the Government Gazette under section 35(1) of the Act, the notice may be published on the following dates:

- (a) 1 December 2016; and
- (b) 1 June 2017.

This Order expires on 31 October 2017.

### MINISTERIAL ORDER UNDER SECTION 42(3B)

I, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change and Minister responsible for administering the **Gas Industry Act 2001** (the Act), specify pursuant to section 42(3B)(a) of the Act, the following dates on which a licensee may publish a notice under section 42(3) of the Act.
