

REVIEW OF ROAD MANAGEMENT PLAN

In accordance with section 54(5) of the **Road Management Act 2004** (Act), the Shire of Campaspe (Council) gives notice that it intends to conduct a review of its Road Management Plan (review).

DECORATIVE ALCOHOL FUELLED BURNERS, DATED 21 DECEMBER 2016

I, Marlene Kairouz MP, Minister for Consumer Affairs, pursuant to section 111(2) of the **Australian Consumer Law (Victoria)**, extend the interim ban order on decorative alcohol fuelled burners, as defined below, issued on 21 December 2016, for a period of 30 days.

The order applied to the following consumer goods:

Particulars of Consumer Goods

Decorative fireplaces, appliances and devices designed for domestic use producing a flame using alcohol as fuel, excluding the following:

- those with a power output of more than 4.5 kW;
- those that require installation in a fixed position; and
- those designed for heating or warming food.

Hazard

That these goods, or a reasonably foreseeable use of these goods, may cause injury to any person.

Interpretation

Decorative fireplaces, appliances and devices designed for domestic use producing a flame using alcohol as fuel are used for heating or display purposes. The fuel is typically ethanol in liquid or (less commonly) gel form. The most common form is methylated spirits (ethanol and around 10% methanol) which may also be marketed as bio-ethanol or eco-fuel.

The effect of this Notice is to extend the interim ban order on decorative alcohol fuelled burners issued in Victoria on 21 December 2016 for a period of 30 days.

The Notice commences with immediate effect on 19 February 2017.



On 30 November 2016, the Licence to operate a Major Hazard Facility MHL 002/03 held by Nufarm Australia Limited for the facility located at 103–105 Pipe Road, Laverton North, Victoria 3026, was amended to MHL 002/05 in accordance with regulation 6.1.33 of the Occupational Health and Safety Regulations 2007. The Licence expires on 7 May 2017.

The following new conditions are attached to the Licence:

1. Nufarm must analyse, to the satisfaction of WorkSafe, past incidents involving loss of containment of chemicals or personal injury since 2010, failure mechanisms associated with such incidents, and incident trends, at the Pipe Road Site and –
 - a) identify specific and systemic causes of such incidents, failure mechanisms, and incident trends; and
 - b) identify any measures or system improvements necessary to prevent reoccurrence of similar or related incidents; and
 - c) identify any measures or system improvements necessary, to ensure the risk from such incidents is reduced so far as is reasonably practicable, and to ensure the continuing and sustainable safe operation of the facility; and
 - d) identify what reduction in risk from such incidents might be achieved by the implementation of measures identified in (b) and (c) above; and
 - e) develop an implementation plan with respect to the measures identified in (b) and (c) above.
2. Nufarm must provide WorkSafe Victoria with a satisfactory written report on or before 1 April 2017 with respect to the matters identified in (1)(a)–(e) above.
3. Nufarm must engage a suitable and independent person to audit the permit to work and management of change elements of the safety management system for the Pipe Road Site, so as to ensure the safety management system continues to be the primary means of managing safety on site. The audit must identify improvements necessary to prevent occurrence of incidents and a timeframe for implementation of these improvements. Nufarm must provide WorkSafe with a satisfactory written report on or before 1 April 2017 with respect to these matters.

Plant Biosecurity Act 2010**ORDER PROHIBITING OR RESTRICTING THE ENTRY OR IMPORTATION OF
TOMATO POTATO PSYLLID HOST MATERIAL INTO VICTORIA**

I, Gabrielle Vivian-Smith, as delegate of the Minister for Agriculture, being of the reasonable suspicion that the exotic pest tomato potato psyllid exists within Australia but outside Victoria, make the following Order:

1 Objective

The objective of this Order is to prohibit, restrict or impose conditions upon the entry or importation into Victoria of tomato potato psyllid host materials.

2 Authorising provision

This Order is made under section 36(1) of the **Plant Biosecurity Act 2010** (the Act).

3 Commencement

This Order comes into force on the day of making.

4 Definitions

In this Order –

‘host material’ means any host plant, and any agricultural equipment or packages used in the cultivation, processing, packaging or transport of any host plant.

‘host plant’ means any plant or plant product belonging to the family Convolvulaceae or Solanaceae.

‘tomato potato psyllid’ means the exotic pest *Bactericera cockerelli* (Sulc).

5 Prohibitions, restrictions and conditions

The following prohibitions, restrictions and conditions are specified in relation to the entry or importation of tomato potato psyllid host material.

- (a) The entry or importation into Victoria of any tomato potato psyllid host material is prohibited.
- (b) Sub-clause (a) does not apply if the tomato potato psyllid host material –
 - (i) was grown on, sourced from or last used on a property that is located in a State or Territory or part of a State or Territory for which an area freedom certificate, issued by an officer responsible for agriculture in the State or Territory where the tomato potato psyllid host material was grown, sourced or last used, is currently in force certifying that the State or Territory or part of the State or Territory is known to be free of tomato potato psyllid; or
 - (ii) is accompanied by a plant health certificate, assurance certificate or plant health declaration, certifying or declaring that the material has been treated in a manner described in Schedule 1.

6 Verification of consignments

Tomato potato psyllid host material imported into Victoria which are required by clause 5(b)(ii) to be accompanied by a certificate or declaration must be:

- (a) presented to an Inspector for inspection; or
- (b) presented for verification by a person accredited to do so by the Department of Economic Development, Jobs, Transport and Resources.

7 Expiry

This Order remains in force for a period of 12 months after the date of making.

Schedule 1

Host material must –

- (1) in the case of fruit of plants belonging to the family Solanaceae, be –
 - (a) fumigated with methyl bromide at:
 - (i) 10°C – 10.9°C @ 56 g/m³ for 2 hours; or
 - (ii) 11°C – 15.9°C @ 48 g/m³ for 2 hours; or
 - (iii) 16°C – 20.9°C @ 40 g/m³ for 2 hours; or
 - (iv) 21°C – 31.9°C @ 32 g/m³ for 2 hours; and
 - (b) inspected and found free of tomato potato psyllid; and
- (2) in the case of plants and plant products belonging to the family Convolvulaceae, excepting tubers, be sourced from a property known to be free of tomato potato psyllid; and
- (3) in the case of tubers from plants belonging to the family Convolvulaceae, be –
 - (a) cleaned free of soil and organic matter by –
 - (i) brushing; or
 - (ii) washing; and
 - (b) inspected and found free of tomato potato psyllid.
- (4) in the case of agricultural equipment and used packages, be cleaned free of soil and organic matter by –
 - (a) brushing; or
 - (b) high pressure water; or
 - (c) steam.

Notes:

Section 38 of the Act provides that it is an offence for a person to cause, permit or assist any plant, plant product, plant vector, used equipment, used package, earth material or beehive to enter Victoria in contravention of an importation order under section 36. The maximum penalty of 60 penalty units applies in the case of a natural person, and 300 penalty units in the case of a body corporate.

Terms in this Order that are defined in the Act have that meaning.

The objective of this Notice is to prohibit absolutely the taking, destroying or hunting in Victoria of indigenous game birds (waterfowl), which would otherwise be permitted during the 2017 open season.

2. Authorising provision

This Notice is made under section 86 of the **Wildlife Act 1975**.

3. Definitions

In this Notice:

2017 open season means the open season in 2017 for indigenous game birds (waterfowl) as prescribed by regulation 29 and Part 3 of Schedule 3 of the Wildlife (Game) Regulations 2012, being from the beginning of Saturday 18 March 2017 to 30 minutes after sunset on Monday 12 June 2017;

indigenous game bird (waterfowl) means any of the following, being the kinds or taxa of game set out in Part 3 of Schedule 3 of the Wildlife (Game) Regulations 2012:

Pacific Black Duck (*Anas superciliosa*), Australasian (Blue-winged) Shoveler (*Anas rhynchosotis*), Chestnut Teal (*Anas castanea*), Grey Teal (*Anas gracilis*), Hardhead (White-eyed Duck) (*Aythya australis*), Australian Shelduck (Mountain Duck) (*Tadorna tadornoides*), Pink-eared Duck (*Malacorhynchus membranaceus*) and Australian Wood Duck (Maned Duck) (*Chenonetta jubata*).

4. Commencement and period notice has effect

This Notice takes effect from the commencement of the 2017 open season and continues to have effect until the end of the 2017 open season.

5. Prohibition on hunting of indigenous game birds (waterfowl)

- (a) The taking, destroying or hunting of the Australasian (Blue-winged) Shoveler (*Anas rhynchosotis*) is prohibited during the 2017 open season, anywhere in Victoria.
- (b) The taking, destroying or hunting of any other indigenous game bird (waterfowl) is prohibited from the beginning of the first day of the 2017 open season until:
 - (i) 7.10 am on that day, east of the line of longitude at 146°30' east; and
 - (ii) 7.20 am on that day between the line of longitude at 146°30' east and the line of longitude at 142°30' east; and
 - (iii) 7.30 am on that day west of the line of longitude at 142°30' east.

6. Contravention of Notice

A person must not contravene any part of this Notice.

Penalty: 25 penalty units.
