Subject to clause 10, an Abalone Fishery Access Licence holder may exceed the individual quota allocated to his or her licence by an amount of no more than 10 kilograms of abalone in a quota period. This additional amount does not apply if the quantity of fish comprising his or her individual abalone quota unit for the quota period is 0.
10. If, under clause 9, the Abalone Fishery Access Licence holder has landed up to 10 kilograms of abalone more than the individual quota allocated to his or her licence, the amount of abalone by which the quota allocated to his or her licence is exceeded must be deducted from the quota allocation applying to that access licence in the following quota period.’.







**Plant Biosecurity Act 2010****ORDER PROHIBITING OR RESTRICTING THE ENTRY OR  
IMPORTATION INTO VICTORIA OF MATERIALS WHICH ARE HOSTS OF  
TOMATO POTATO PSYLLID AND ZEBRA CHIP**

I, Gabrielle Vivian-Smith, as delegate of the Minister for Agriculture, being of the reasonable suspicion that the exotic pest tomato potato psyllid and the exotic disease zebra chip exist within Australia but outside Victoria, make the following Order:

**1 Objective**

The objective of this Order is to prohibit, restrict or impose conditions upon the entry or importation into Victoria of materials which are hosts of tomato potato psyllid and zebra chip.

**2 Authorising provision**

This Order is made under section 36(1) of the **Plant Biosecurity Act 2010** (the Act).

**3 Commencement**

This Order comes into force on the day of making.

**4 Revocation**

The Order made under section 36(1) of the **Plant Biosecurity Act 2010**, prohibiting or restricting the entry or importation into Victoria materials which are hosts of tomato potato psyllid and zebra chip, and published in Victoria Government Gazette G13 on 30 March 2017 at pages 545–546 is **revoked**.

**5 Definitions**

In this Order –

‘Category 1 plant’ means all plants belonging to the family *Convolvulaceae*, *Lamiaceae* or *Solanaceae*.

‘Category 2 plant’ means all plants belonging to the family *Amaranthaceae*, *Apiaceae*, *Asclepiadaceae*, *Asparagaceae*, *Asteraceae*, *Boraginaceae*, *Brassicaceae*, *Caprifoliaceae*, *Chenopodiaceae*, *Cupressaceae*, *Ephedraceae*, *Ericaceae*, *Fabaceae*, *Garryaceae*, *Grossulariaceae*, *Malvaceae*, *Oleaceae*, *Pinaceae*, *Plantaginaceae*, *Poaceae*, *Polygonaceae*, *Ranunculaceae*, *Rosaceae*, *Salicaceae*, *Sapindaceae*, *Violaceae*, *Vitaceae* or *Zygophyllaceae*.

‘**host material**’ means any host plant, and any agricultural equipment or package used in the cultivation, processing, packaging or transport of any host plant.

‘**host plant**’ means any Category 1 plant, or plant product of such plants (including fruit and vegetables for consumption, cut flowers and potatoes (seed and ware), but excluding dried or processed plant products such as chaff, dried herbs, grain, hay, mulch, seed or timber); and any Category 2 plants, or plant product of such plants (including fruit and vegetables for consumption and cut flowers but excluding pome fruit that are free of vegetative material and dried or processed plant products such as chaff, dried herbs, grain, hay, mulch, seed, timber).

‘**pome fruit**’ means the fruit of plants belonging to the family *Rosaceae*.

‘**tomato potato psyllid**’ means the pest *Bactericera cockerelli* (Sulc).

‘unit’ means each individual item, such as in the case of fruit, an individual piece of fruit and in the case of plants, an individual plant.

‘**zebra chip**’ means the disease caused by the bacterium *Candidatus Liberibacter solanacearum*.

**6 Prohibitions, restrictions and conditions**

The following prohibitions, restrictions and conditions are specified in relation to the entry or importation of host materials.

- (a) The entry or importation into Victoria of any host material is prohibited.

- (b) Sub-clause (a) does not apply if the host material –
  - (i) was grown on, sourced from or last used on a property that is located in a State or Territory or part of a State or Territory for which an area freedom certificate, issued by an officer responsible for agriculture in the State or Territory where the host material was grown, sourced or last used, is currently in force certifying that the State or Territory or part of the State or Territory is known to be free of tomato potato psyllid and zebra chip; or
  - (ii) is accompanied by a plant health certificate, assurance certificate or plant health declaration, certifying or declaring that the material has been treated in a manner described in the Schedule to this Order; or
  - (iii) enters Victoria under and in accordance with a permit issued by an inspector and there is compliance with any conditions or requirements set out in the permit.

## 7 Verification of consignments

Host material imported into Victoria which is required by Clause 6(b)(ii) to be accompanied by a certificate or declaration must be:

- (a) presented to an Inspector for inspection; or
- (b) presented for verification by a person accredited to do so by the Department of Economic Development, Jobs, Transport and Resources.

## 8 Expiry

This Order remains in force for a period of 12 months after the date of making.

### Schedule

Host material must –

- (1) in the case of flowers, foliage (including herbs and fresh leafy vegetables) or fruit of a Category 1 plant, be –
  - (a) fumigated with methyl bromide at:
    - (i) 10°C – 10.9°C @ 56g/m<sup>3</sup> for 2 hours; or
    - (ii) 11°C – 15.9°C @ 48g/m<sup>3</sup> for 2 hours; or
    - (iii) 16°C – 20.9°C @ 40g/m<sup>3</sup> for 2 hours; or
    - (iv) 21°C – 31.9°C @ 32g/m<sup>3</sup> for 2 hours; and
  - (b) undergo a 600 unit inspection and be found free of –
    - (i) tomato potato psyllid; and
    - (ii) symptoms of zebra chip; and
- (2) in the case of plants, flowers, foliage (including herbs and fresh leafy vegetables) or fruit of a Category 2 plant, be –
  - (a) fumigated with methyl bromide at:
    - (i) 10°C – 10.9°C @ 56g/m<sup>3</sup> for 2 hours; or
    - (ii) 11°C – 15.9°C @ 48g/m<sup>3</sup> for 2 hours; or
    - (iii) 16°C – 20.9°C @ 40g/m<sup>3</sup> for 2 hours; or
    - (iv) 21°C – 31.9°C @ 32g/m<sup>3</sup> for 2 hours; and
  - (b) undergo a 600 unit post-harvest inspection and be found free of –
    - (i) tomato potato psyllid; and
    - (ii) symptoms of zebra chip; and

- (3) in the case of strawberries, must –
  - (a) be securely packed following sorting and grading; and
  - (b) undergo a 600 unit post-harvest inspection and found free of TPP; and
- (4) in the case of agricultural equipment and used packages be cleaned free of soil and organic matter by –
  - (a) brushing; or
  - (b) high pressure water; or
  - (c) steam.

**Notes:**

Section 38 of the Act provides that it is an offence for a person to cause, permit or assist any plant, plant product, plant vector, used equipment, used package, earth material or beehive to enter Victoria in contravention of an importation order under section 36. The maximum penalty of 60 penalty units applies in the case of a natural person, and 300 penalty units in the case of a body corporate.

Terms in this Order that are defined in the Act have that meaning.

**Citation**

1. This Declaration is called the Carryover Declaration for Murrayville Groundwater Management Area 2017.

**Authorising provision**

2. This Declaration is made under section 62A of the **Water Act 1989**.

**Purpose**

3. The purpose of this Declaration is to allow the holders of groundwater licences in the Murrayville Groundwater Management Area to carry over an amount of groundwater unused in a water season to a subsequent water season and to specify the condition that is to apply to ensure amongst other things that the local impacts of any increased extraction can be managed.

**Commencement and duration**

4. This Declaration commences on the day it is published in the Victoria Government Gazette and continues in force until revoked.

**Definitions**

5. In this Declaration:

‘**Act**’ means the **Water Act 1989**;

‘**Authority**’ means the Grampians Wimmera Mallee Water Corporation;

‘**carryover water**’ means the amount of groundwater authorised to be taken by a licence holder under this Declaration;

‘**Declaration**’ means this Carryover Declaration for Murrayville Groundwater Management Area 2017;

‘**groundwater licence**’ means a licence to take and use groundwater issued under section 51(1)(b) of the Act;

‘**licensed volume**’ means the maximum amount of groundwater authorised to be taken under a groundwater licence in a water season;

‘**Murrayville Groundwater Management Area**’ means that part of the groundwater system that is the area known as the Murrayville Groundwater Management Area and identified as the Murrayville Groundwater Management Area in Plan No. LEGL./16-483 lodged in the Central Plan Office.

### Declaration

6. I declare that groundwater licence holders in the Murrayville Groundwater Management Area are authorised to take groundwater that has not been taken under a groundwater licence by the end of a water season in the subsequent water season (that is, it may be ‘carried over’ into the next water season) subject to the condition specified in this Declaration.

### Condition

7. The maximum amount of carryover water that can be taken in the subsequent water season is 30 percent of the licensed volume.

### Agricultural and Veterinary Chemicals (Control of Use) Act 1992

#### ORDER REGULATING THE USE OF SPECIFIED CHEMICAL PRODUCTS UNDER CERTAIN LICENCES AND PERMITS

##### Order in Council

The Lieutenant-Governor, as the Governor's deputy, with the advice of the Executive Council makes the following Order:

**1 Purposes**

The purpose of this Order is to regulate the use of specified chemical products under certain circumstances and subject to certain conditions.

**2 Authorising provision**

This Order is made under section 25A of the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992**.

**3 Commencement**

This Order comes into operation on 23 July 2017.

**4 Revocation**

The Order entitled *Order Regulating the Use of Agricultural Products by Authorised Personnel* made on 11 December 2001 and published in Government Gazette No. G50 on 13 December 2001, page 3106, is **revoked**.

**5 Definitions**

In this Order –

**APVMA** means the Australian Pesticides and Veterinary Medicines Authority continued in existence by section 6 of the **Agricultural and Veterinary Chemicals (Administration) Act 1992** of the Commonwealth;

**home garden product** means an agricultural chemical product that is –

- (a) packaged and supplied to the general public for use in and around dwellings; and
- (b) specified, on a label approved by the APVMA, for use in the home garden;

**regulated chemical product** means a chemical product, or a chemical product of a class, that is specified in the Table in clause 6;

**the Act** means the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992**.

**6 Regulation on use of chemical products**

Subject to clause 7, the use of an agricultural chemical product (other than a home garden product) that is of a class, or contains a constituent that is specified in the following table is **prohibited**.

**7 Circumstances under which regulated chemical products are permitted to be used**

Clause 6 does not apply to a person who uses a regulated chemical product –

- (a) under and in accordance with a pest control licence issued under Division 2 of Part 7 of the **Public Health and Wellbeing Act 2008**; or
- (b) in accordance with a permit referred to in section 25A(2)(b) of the Act and issued under Schedule 1 to the Act; or
- (c) while acting under the direct and immediate supervision of a person referred to in paragraph (b); or
- (d) in accordance with a commercial operator licence referred to in section 31 of the Act and issued under Schedule 1 to the Act; or
- (e) an employee of a person referred to in paragraph (d) who is acting under and in accordance with that licence; or
- (f) by conducting aerial spraying under and in accordance with a pilot (chemical rating) licence referred to in section 42 of the Act and issued under Schedule 1 to the Act.

**Agricultural and Veterinary Chemicals (Control of Use) Act 1992****ORDER PROHIBITING AND REGULATING THE USE OF CHEMICAL PRODUCTS CONTAINING SODIUM FLUOROACETATE (1080) OR 4-AMINOPROPIOPHENONE (PAPP)****Order in Council**

The Lieutenant-Governor, as the Governor's deputy, with the advice of the Executive Council makes the following Order:

**1 Purpose**

The purpose of this Order is to regulate the use of chemical products containing –

- (a) sodium fluoroacetate (1080); or
- (b) 4-aminopropiophenone (PAPP).

**2 Authorising provision**

This Order is made under section 25A of the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992**.

**3 Commencement**

This Order comes into operation on 23 July 2017.

**4 Revocation**

The Order entitled *Order Regulating the Use of Perishable Pest Animal Baits Containing Sodium Fluoroacetate (1080)* made on 18 December 2007 and published in Government Gazette No. G51 on 20 December 2007, pages 3181–3182, is **revoked**.

**5 Definitions**

In this Order –

**Accredited 1080 and PAPP training course** means the '22275VIC Course in Minimising Risks in the Use of 1080 Pest Animal Bait Products for Vertebrate Pest Control' or the '21835VIC Course in Minimising the Risks in the Use of 1080 Pest Animal Bait Products for Vertebrate Pest Control', accredited by the Victorian Registration and Qualifications Authority under Chapter 4 of the **Education and Training Reform Act 2006**;

**Act** means the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992**;

**AgVet Code of Victoria** has the same meaning as in the **Agricultural and Veterinary Chemicals (Victoria) Act 1994**;

**laid**, in relation to bait, means placement of the pest animal bait product in the landscape, including burial and surface placement of bait by aerial, broadcast, trail application or the setting of a canid pest ejector;

**perishable pest animal bait** means a bait that has a short shelf life and is intended to be used to control a pest animal;

**pest animal** means a pest animal declared in accordance with Part 8 of the **Catchment and Land Protection Act 1994**;

**1080 and PAPP Directions for Use** means the current document entitled *Directions for the Use of 1080 and PAPP Pest Animal Bait Products in Victoria*, authorised and published by Department of Economic Development, Jobs, Transport and Resources, 1 Spring Street, Melbourne.

**6 Prohibition on use of chemical products containing 1080 and PAPP**

Subject to clauses 7 and 8, the use of an agricultural chemical product containing sodium fluoroacetate (1080) or 4-aminopropiophenone (PAPP) is **prohibited**.

**7 Conditions of use of agricultural chemical products containing sodium fluoroacetate (1080) and 4-aminopropiophenone (PAPP)**

(1) Clause 6 does not apply to a person who uses an agricultural chemical product containing sodium fluoroacetate (1080) or 4-aminopropiophenone (PAPP) if the person who uses that product –

- (a) is acting under and in accordance with a permit issued under section 25A(2)(b) and Schedule 1 to the Act; or
- (b) is acting under and in accordance with a permit issued under Part 7 of the Schedule to the AgVet Code; or
- (c) is manufacturing a perishable pest animal bait containing 1080, under and in accordance with a licence issued under the **Drugs, Poisons and Controlled Substances Act 1981**.

(2) Clause 6 does not apply to a person who uses an agricultural chemical product containing sodium fluoroacetate (1080) or 4-aminopropiophenone (PAPP) in accordance with the **1080 and PAPP Directions for Use** and the person –

- (a) is acting under and in accordance with a pest control licence issued under Division 2 of Part 7 of the **Public Health and Wellbeing Act 2008** and is operating in accordance with the provisions of that Act and Regulations made under that Act; or
- (b) is acting under and in accordance with a current permit authorising the use of 1080, issued under section 25A(2)(b) and Schedule 1 to the Act, or is operating under the direct and immediate supervision of a person who holds such a permit; or
- (c) is acting under and in accordance with a current pilot (chemical rating) licence issued under section 42 and Schedule 1 to the Act and has successfully completed the accredited 1080 and PAPP training course; or
- (d) is acting under and in accordance with a current commercial operator licence issued under section 31 and Schedule 1 to the Act and has successfully completed the accredited 1080 and PAPP training course.

**8 Conditions of use of perishable pest animal baits**

The use of a perishable pest animal bait containing sodium fluoroacetate (1080) is subject to the following conditions –

- (a) the bait must be prepared from a base that is specified in Column 1 of the following Table; and

- (b) the bait and base specified in Column 1 of the Table may only be used to control the pest animal specified in Column 2 of the Table that corresponds to that bait base; and
- (c) each bait must have a visible coating of blue or green dye; and
- (d) the bait must be laid within 3 days of the date of manufacture of the bait, except for a bait prepared from a base of grain for the control of feral pigs.

Note: Section 25A(1) of the Act provides for a penalty of 400 penalty units in the case of a corporation, and in any other case, 200 penalty units, for contravening an Order under that section.

**Plant Biosecurity Act 2010**  
ORDER DECLARING CONTROL AREAS IN VICTORIA FOR THE  
CONTROL OF GRAPE PHYLLOXERA

Order in Council

The Lieutenant-Governor, as the Governor's deputy, with the advice of the Executive Council, under section 19(1) of the **Plant Biosecurity Act 2010**, makes the following Order –

**1 Purpose**

The purpose of this Order is to declare control areas in Victoria for the purposes of preventing the spread of the pest grape phylloxera from the control areas to other parts of Victoria.

**2 Authorising provision**

This Order is made under section 19(1) of the **Plant Biosecurity Act 2010**.

**3 Commencement**

This Order comes into operation on the day it is published in the Government Gazette.

**4 Revocation**

The Order made under section 19(1) of the **Plant Biosecurity Act 2010** declaring areas in Victoria to be control areas for the purpose of preventing the spread of grape phylloxera, and published in Victoria Government Gazette G13 on 30 March 2017 at pages 561–565, is **revoked**.

**5 Definitions**

In this Order –

**'grape phylloxera'** means the pest *Daktulosphaira vitifoliae* (Fitch);

**'host material'** means host plants; and earth material, package or used equipment associated with the cultivation, harvesting, handling, transport or processing of host plants;

**'host plant'** means plants and plant products of the genus *Vitis*, including potted vines, cuttings, rootlings, grapes, grape marc, grape must and germplasm.

**6 Declaration of control areas for preventing the spread of grape phylloxera to other parts of Victoria**

- (1) The area described in Schedule 1, known as the North East Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.
- (2) The area described in Schedule 2, known as the Nagambie Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.
- (3) The area described in Schedule 3, known as the Upton Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.
- (4) The area described in Schedule 4, known as the Mooroopna Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.
- (5) The area described in Schedule 5, known as the Maroondah Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.
- (6) The area described in Schedule 6, known as the Whitebridge Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.

**7 Prohibitions, restrictions and requirements to apply in a control area**

- (1) For the purpose of preventing the spread of the pest grape phylloxera from a control area described in clause 6, the removal of any host material from a control area is prohibited.
- (2) Subclause (1) does not apply to a person who removes table grapes from a control area described in clause 6 that have been treated for the control of grape phylloxera in accordance with the Act.

The area of land bounded by a line commencing at the intersection of the boundaries of the parishes of Dueran East, Toombullup and Whitfield South, then in a northerly direction along the western boundary of the parish of Whitfield South to the intersection of the boundaries of the parishes of Whitfield South, Toombullup and Toombullup North, then in a westerly, then northerly, then easterly direction along the southern, western and northern boundaries of the parish of Toombullup North to the intersection of the boundaries of the parishes of Toombullup North, Rothsay and Tatong, then in a generally northerly direction along the western boundaries of the parish of Tatong, Lurg, Winton, Mokoan, Boweya, Boomahnoomoonah and Bundalong to the intersection of the western boundary of the parish of Bundalong and the Murray River, then in a generally easterly direction along the Murray River to the intersection of the Murray River and the eastern boundary of the parish of Wodonga, then in a generally southerly direction along the eastern boundaries of the parishes of Wodonga, Baranduda, Yackandandah and Bruarong to the intersection of the boundaries of the parishes of Bruarong, Kergunyah and Dederang, then in a straight line in a southerly direction to the intersection of Lambert Lane and Mt Jack Track, then in a southerly direction along Mt Jack Track to the intersection of Mt Jack Track and Running Creek Road, then in a westerly direction along Running Creek Road to the intersection of Running Creek Road and Kancoona Gap Track, then in a southerly direction along Kancoona Gap Track to the intersection of Kancoona Gap Track and Link Road, then in a westerly direction along Link Road to the intersection of Link Road and Barker Road, then in a generally southerly direction along Barker Road to the intersection of Barker Road and Rolland Road, then in a straight line in a south easterly direction to the intersection of Kancoona South Road and Havilah Road, then in a south easterly direction along Havilah Road to the intersection of Havilah Road and Mt Porepunkah Road, then in a southerly direction along Mt Porepunkah Road to the intersection of Mt Porepunkah Road and Smart Creek–Tawonga Gap Track, then in a south easterly direction along Smart Creek–Tawonga Gap Track to the intersection of Smart Creek–Tawonga Gap Track and Tawonga Gap Track, then in a southerly direction along Tawonga Gap Track to the intersection of Tawonga Gap Track and Big Flat Track, then in a south easterly direction along Big Flat Track to the intersection of Big Flat Track and Dungey Track, then in a straight line in a southerly direction to the intersection of Razorback Walking Track and Razorback Track, then in a south westerly direction along Razorback Track to the intersection of Razorback Track and Bungalow Spur Walking Track, then in a straight line in a south westerly direction to the intersection of Cobbler Lake Track and Cobbler Lake Track and Abbeyards Road, then in a straight line in a north westerly direction to the intersection of the boundaries of the parishes of Matong North, Dandongadale and Winteriga, then in a generally westerly direction along the southern boundary of the parish of Winteriga to the intersection of the boundaries of the parishes of Winteriga, Matong North and Wabonga, then in a southern, then westerly direction along the eastern, then southern boundary of the parish of Wabonga to the intersection of the parishes of Wabonga, Whitfield South and Cambatong, then in a southerly direction along the western boundary of the parish of Cambatong to the intersection of the boundaries of the parishes of Cambatong, Dueran East and Merrijig, then in a westerly direction along the northern boundary of the parish of Merrijig to the intersection of the boundaries of the parishes of Merrijig, Dueran East and Gonzaga, then in a southerly, then westerly direction along the eastern then southern boundaries of the parish of Gonzaga to the intersection of the southern boundary of the parish of Gonzaga and Glenroy Road, then in a south westerly direction along Glenroy Road to the intersection of Glenroy Road and Mt Buller Road, then in a westerly direction

along Mt Buller Road to the intersection of Mt Buller Road and Scullys Lane, then in a northerly direction along Scullys Lane to the intersection of Scullys Lane and Graves Road, then in a westerly direction along Graves Road to the intersection of Graves Road and Old Tolmie Road, then in a straight line in a north westerly direction to the intersection of Saligari Road and Barwite Road, then in a westerly direction along Barwite Road to the intersection of Barwite Road and Mansfield–Whitfield Road, then in a northerly, then north easterly direction along Mansfield–Whitfield Road to the intersection of the Mansfield–Whitfield Road and the southern boundary of the parish of Toombullup, then in an easterly direction along the southern boundary of the parish of Toombullup to the point of commencement.

The area of land bounded by a line commencing at the intersection of Three Chain Road and Bolgers Lane, then in a southerly direction along Bolgers Lane to the intersection of Bolgers Lane and Rochford Road, then in an easterly direction along Rochford Road to the intersection of Rochford Road and Monument Creek Road, then in a southerly direction along Monument Creek Road to the intersection of Monument Creek Road and Ochiltrees Road, then in an easterly direction along Ochiltrees Road to the intersection of Ochiltrees Road and Lukes Road, then in a northerly direction along Lukes Road to the intersection of Lukes Road and Boundary Road, then in an easterly direction along Boundary Road to the intersection of Boundary Road and Parks Road, then in a northerly direction along Parks Road to the intersection of Parks Road and McMasters Lane, then in a north easterly direction along McMasters Lane to the intersection of McMasters Lane and Three Chain Road, then in a generally westerly direction along Three Chain Road to the point of commencement.

**Note:**

Section 20(1) of the Act provides an offence for a person who causes or permits the movement of any plant, plant product, used package, used equipment or earth material into or from a control area or within a control area or within a specified part of a control area contrary to any prohibition or restriction in an order declaring an area to be a control area if the person knows or may reasonably be expected to know that the place has been declared to be a control area, unless the person is authorised to do so under a permit issued by the Secretary. The maximum penalty for this offence is 60 penalty units in the case of an individual and 300 penalty units in the case of a body corporate.

Under section 20(2) of the Act, it is an offence for a person to transport, move or take any plant, plant product, used package, used equipment or earth material into or out of a control area, past a sign posted on or within sight of a public highway passing in or out of a control area contrary to a prohibition in an order if the sign indicates that the movement of those items into or out of the control area is prohibited. A penalty of 10 penalty units applies.

Section 20(3) of the Act provides that a person who contravenes any prohibition or restriction in an order declaring a place to be a control area, where that person is not liable for the offence in section 20(1) of the Act, is guilty of an offence and is liable to a penalty not exceeding 10 penalty units in the case of an individual and 60 penalty units in the case of a body corporate, unless the person is authorised to do so under a permit issued by the Secretary and complies with the conditions of that permit.
