

#### **ELECTRICITY SUPPLY AND DISTRIBUTION EXEMPTION FOR ACTIVITIES ASSOCIATED WITH THE NATIONAL BROADBAND NETWORK**

  - a. a person subject to this exemption must provide (whether or not through an agent), to the Minister or the Essential Services Commission, any information that either entity may reasonably require for the administration of this Order; and
  - b. a person subject to this exemption must comply with the Electricity Distribution Code that is specified by the Essential Services Commission as provisions applicable to an exempt person of that category or class.
3. In this Order, National Broadband Network means services provided by NBNco Ltd (ABN 86 136 533 741).
4. This Order comes into effect from the date it is published in the Government Gazette
5. This Order will continue in effect until 1 July 2018, unless otherwise revoked.
