#### NOTICE OF REGULATORY IMPACT STATEMENT

Appointment of Christmas Day as a public holiday when it falls on a Saturday or Sunday

Notice is given under section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared in relation to a proposal to appoint Christmas Day a public holiday when it falls on the Saturday or Sunday.

#### **Objectives**

The proposal seeks to provide for fair pay to those working on Christmas Day irrespective of when it occurs (on a weekday or a weekend); increase opportunities for Victorians to enjoy coordinated leisure time with family and friends; to allow for consistent treatment of all significant cultural days observed in Victoria; and acknowledge the important role performed by public holidays on such days in uniting the community.

The RIS assesses the likely impacts, and estimates the costs and benefits of the proposed change.

#### **Submissions**

Submissions on the RIS are invited, and must be received no later than 5.00 pm on 20 July 2017. Submissions will be considered before any formal legislative change is undertaken.
