I, LINDA DESSAU AC, Governor in and over the State of Victoria and its Dependencies in the Commonwealth of Australia, under section 7 of the **Australia Acts 1986** of the Commonwealth of Australia and of the United Kingdom and the **Constitution Act 1975** of the State of Victoria, by this my Commission under the Public Seal of the State of Victoria, hereby appoint you, KENNETH DOUGLAS LAY AO APM to be, during the Governor's pleasure, the Lieutenant-Governor of the State of Victoria, in the Commonwealth of Australia and you are authorised and empowered to perform the powers and functions of the Office of the Lieutenant-Governor in accordance with the **Constitution Act 1975** of Victoria, the **Australia Acts 1986** of the Commonwealth of Australia and of the United Kingdom, and all other applicable laws.

AND this Commission shall supersede the Commission dated 4 April 2006 appointing THE HONOURABLE MARILYN LOUISE WARREN AC to be Lieutenant Governor of the State of Victoria on 9 November 2017 or, if you have not taken the prescribed Oath or Affirmation before that date, as soon as you have taken that Oath or Affirmation.

AND I hereby command all Victorians and all other persons who may lawfully be required to do so to give due respect and obedience to the Lieutenant-Governor accordingly.
