





GOVERNMENT ROAD




Erratum – Notice of Road Discontinuance

- Deleting the plan contained in the original Gazettal Notice and replacing it with the following plan.









PROPOSED ROAD MANAGEMENT PLAN

Cardinia Shire Council ('Council') is proposing to:

1. revoke the Road Management Plan which it made on 17 August 2009; and
2. make a new Road Management Plan ('the proposed RMP').

The purpose of the proposed RMP is to detail the management systems for Council's road management functions, set relevant standards for the discharge of duties in the performance of these functions, base the standards on policy and operational objectives within the resources available and ensure the provisions of the safe and efficient road network for use by road users and the community more generally.

If made, the proposed RMP will:

- set out a schedule of maintenance standards;
- describe a work flow process concerning inspections, work planning, scheduling of repairs and maintenance and monitoring; and
- refer to Council's register of public roads

in relation to road pavements and surfaces, pathways, bridges, traffic signs and road-related drainage infrastructure.

EXEMPTION

Application No. H298/2018

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by International Women's Development Agency (the applicant). The application for exemption is to enable the applicant to advertise for and employ females in all roles within the applicant organisation (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Kirsten Mander dated 30 August 2018 and having regard to the material attached to the affidavit, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- The applicant is an international development agency working for the elimination of poverty and for the empowerment of women around the world. The applicant assists women internationally to develop skills and gain access to resources and promotes projects and programs which demonstrate

women's competence and effectiveness as agents of development in agriculture, marketing, manufacturing, health, education, water supply, housing and other fields. The applicant is a non-profit organisation which undertakes development in partnership with women of other countries and gives priority to working with women who suffer poverty and oppression.

- It is important that female field workers be employed in the agency's international development projects because of cultural sensitivities in relation to the women in the countries where those projects are undertaken. The Tribunal accepts that women in those countries will be more likely to communicate freely with the field workers if those workers are also women. Further, it is important to make local positions with the agency available to women only to encourage the self-development of Australian women and to provide them with additional career paths.
- Previous exemptions have been granted to the applicant in similar terms. The current interim exemption will expire on 4 October 2018. The circumstances and manner in which the applicant works have not altered in any way since the grant of the previous long-term exemption in July 2015.
- I am satisfied that, where services provided by the applicant are for the benefit of women, those services are special needs services within the meaning of section 88 of the Act. I am also satisfied that, where staff are dealing with women who might not engage with any male staff, the exception contained in section 28 of the Act applies, as those services are likely to be most effectively provided by other women. However, in the case of administrative and other roles, where that female to female contact is not essential, I am not satisfied that those roles can be most effectively performed only by women. Where I am not satisfied that an exception applies to the whole of the exempt conduct but accept that the women the applicant seeks to assist are likely to respond best to services and assistance from a women-only organisation and noting that the applicant organisation seeks to provide employment opportunities to women in this particular

field, it is appropriate that an exemption be granted. In the absence of an exemption the exempt conduct would amount to prohibited discrimination.

- I am not satisfied it is appropriate to grant an exemption for the maximum allowable five years as some of the facts relied on in the application concern the context provided by other organisations and events, which may be subject to change within that period.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of males who would wish to be employed by the applicant. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which the notice of the exemption is published in the Government Gazette until 20 September 2021.

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES

1 Purpose

The purpose of this Declaration is to exempt participants in the Volkswagen Amarok Launch from specified provisions of the Road Safety Road Rules 2017 and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the arterial roads listed in Table 2 on Wednesday 26 September 2018.

2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

3 Commencement

This notice takes effect on Wednesday 26 September 2018 at 9.30 am.

4 Expiry

This notice expires on Wednesday 26 September 2018 at 2.00 pm.

5 Definitions

In this notice, unless the context or subject-matter otherwise requires –

- a) ‘Event’ means the Volkswagen Amarok Launch, to be held on Wednesday 26 September 2018; and
- b) ‘Participants’ means participants in the Event, including officers, members and authorised agents of the Volkswagen Amarok Launch whose presence is reasonably required to ensure the safe conduct of the Event.

6 Declaration

I, Nicki Kyriakou, as delegate of the Minister for Roads and Road Safety, under section 99B(4) of the **Road Safety Act 1986**, declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by VicRoads and the municipal council.
