### NOTICE OF INTENTION TO DECLARE THE FRESHWATER FISHERIES MANAGEMENT PLAN

I, Travis Dowling, Chief Executive Officer, Victorian Fisheries Authority, as delegate of the Minister for Agriculture, announce my intention to declare the Freshwater Fisheries Management Plan (the Management Plan) and give notice of the imminent release of the Draft Freshwater Fisheries Management Plan (the draft Management Plan) for the purpose of receiving public comment under section 32 of the **Fisheries Act 1995** ('the Act'). This fishery management plan is being developed under Part 3 of the Act.

The Management Plan will provide priorities and management direction for the Victoria's freshwater recreational fisheries and is being prepared with assistance from a key stakeholder- and expert-based steering committee.
