## Marine Safety Act 2010 Section 211(1)(b)

### NOTICE CONTROLLING NAVIGATION IN THE VICINITY OF WORKS

I, Rachel Gualano, Acting Director Maritime Safety, as delegate of the Director, Transport Safety, make the following notice under section 211(1)(b) of the **Marine Safety Act 2010**.

For the purposes of the survey, works activity proposed by Department of Economic Development, Jobs, Transport and Resources of the Victorian State Government and being undertaken by RPS Energy Pty Ltd off shore of Golden Beach, East Gippsland, within the area as detailed in Table 1, the following rules apply to the navigation and movement of vessels.

**Exclusion Zone** – Persons and the navigation and other movement of vessels including drifting, or anchoring within 4.5 nm of the Polarcus Naila when the Polarcus Naila is undertaking survey activities within the area detailed in **Table 1** is prohibited, excluding persons and vessels engaged in the survey and support activities.
