Notice of Approval of Amendment

Amendment C119

The Minister for Planning has approved Amendment C119 to the Frankston Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment facilitates the redevelopment of Frankston Station, Frankston by:

- introducing the 'Improve Frankston Station Project, Incorporated Document, February 2018' into the Frankston Planning Scheme to allow for the use and redevelopment of Frankston Station; and
- rezoning a portion of land at 69C Young Street, Frankston, from Commercial 1 Zone (C1Z/B1Z) to Public Use Zone (PUZ4).

Amendment C237

The Minister for Planning has approved Amendment C237 to the Yarra Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment introduces built form controls for part of the Johnston Street Activity Centre by introducing Design and Development Overlay Schedule 15 and applies the Heritage Overlay to the Johnston Street East Precinct (HO505) on an interim basis until 31 December 2019.
