SCHEDULE TO THE ORDER IN COUNCIL

1. Appointment Arrangements

The appointment is full-time.

2. The Period of Appointment

The appointment of Ernst & Young (ABN 75 288 172 749) is for a period of twelve months from the date of publication of the Order of Council in the Government Gazette.

3. Responsibilities and Duties

Section 102(4) of the **Disability Act 2006** (the Act) provides that the administrator is deemed to be the committee of management of the disability service provider and has all the powers and may exercise any of the duties of the committee of management.

4. Termination Arrangements

Section 102(10)(b) of the Act provides that the Governor in Council may at any time declare that the administrator ceases to be the administrator

5. Payment Provisions

Section 102(8) of the Act provides that the salary of the administrator and any expenses of the administrator necessarily incurred in the administration are to be paid by the Secretary to the Department of Health and Human Services.

There are no leave provisions for this position.
