FRENCH ISLAND AND SANDSTONE ISLAND PLANNING SCHEME

Notice of the Preparation of an Amendment

Amendment C6

The Minister for Planning has prepared Amendment C6 to the French Island and Sandstone Island Planning Scheme.

The land affected by the Amendment is French Island, Sandstone Island and Elizabeth Island.

The Amendment proposes to implement the recommendations of the French Island and Sandstone Island Planning Scheme Review 2017 by updating the Local Planning Policy Framework at Clause 21; updating Schedules 1–3 to the Environmental Significance Overlay (ESO) at Clause 42.01 and applying the ESO to a number of properties on French Island; and introducing and applying three new schedules to the Significant Landscape Overlay at Clause 42.03.

You may inspect the Amendment, any documents that support the Amendment and the explanatory report about the Amendment, free of charge, at the following locations: during office hours, at the office of the planning authority, Department of Environment, Land, Water and Planning, 71 Hotham Street, Traralgon, and 12 Peart Street, Leongatha; at the Department of Environment, Land, Water and Planning website, www.delwp.vic.gov.au/public-inspection

Any person who may be affected by the Amendment may make a submission to the planning authority about the Amendment. Submissions must be made in writing giving the submitter's name and contact address, clearly stating the grounds on which the Amendment is supported or opposed and indicating what changes (if any) the submitter wishes to make.

Name and contact details of submitters are required for the Minister for Planning to consider submissions and to notify such persons of the opportunity to attend any public hearing held to consider submissions. The closing date for submissions is 18 May 2018. A submission must be sent to the Minister for Planning, care of Department of Environment, Land, Water and Planning, 71 Hotham Street, Traralgon 3844.

The planning authority must make a copy of every submission available at its office for any person to inspect, free of charge, for two months after the Amendment comes into operation or lapses.
