Amendment C209

The Minister for Planning has approved Amendment C209 to the Greater Shepparton Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment is a corrections amendment that reinstates the correct version of three clauses of the planning scheme that were inadvertently removed at gazettal of Amendment C197.

The Amendment replaces Clause 21.06, Clause 21.09 and the Schedule to Clause 37.08 with new clauses, including changes approved as part of Amendment C192.
