## Education and Training Reform Act 2006

MINISTERIAL ORDER NO. 1148

Victorian Institute of Teaching Registration Fees 2018–19

The Minister for Education makes the following Order:

**1. Purpose**

The purpose of this Order is to fix the annual registration fee payable by registered teachers and early childhood teachers including those having permission to teach and the fees which must be paid under Part 2.6 of the **Education and Training Reform Act 2006** ('Act').

**2. Authorising provisions**

This Order is made under Part 2.6, including section 2.6.77, section 5.10.4, and Clause 3 of Schedule 6 of the Act.

**3. Interpretation**

References to sections in clause 5 of this Order are references to sections in the Act.

**4. Period of fee**

The fees in clause 5 are for the 12-month period commencing 1 September 2018.

**5. Fees**

The following fees are fixed for a period of twelve (12) months pursuant to section 2.6.77 of the Act:

Initial registration (applicants with Victorian qualifications)/permission to teach pursuant to sections 2.6.7(2), 2.6.13(2) and 2.6.12A(2)*	<b>\$128.08</b>
Initial registration (applicants with interstate or overseas qualifications)/permission to teach pursuant to sections 2.6.7(2) and 2.6.13(2)*	<b>\$148.40</b>
Application for second registration, pursuant to section 2.6.7(2), 2.6.12A(2) and 2.6.77A	<b>\$30.49</b>
Annual registration/renewal of registration if paid by 30 September 2018 pursuant to sections 2.6.18 and 2.6.21**	<b>\$95.55</b>
Annual registration/renewal of registration if paid from 1 October to 31 December 2018 which incorporates the late processing fee pursuant to sections 2.6.18 and 2.6.21**	<b>\$126.04</b>
Annual registration/renewal of registration for second registration pursuant to section 2.6.18, 2.6.21 and 2.6.77**	<b>\$22.36</b>
Criminal Record Check (known as the National Police History Check) pursuant to section 2.6.22A(2)	<b>\$54.89</b>
Additional fee and late processing fee pursuant to sections 2.6.18 and 2.6.21	<b>\$30.49</b>
Replacement of registration card processing fee pursuant to section 2.6.4(2)(g)	<b>\$22.36</b>
Course accreditation pursuant to section 2.6.4(2)(g)	<b>\$2,250.53</b>
Statement of good standing pursuant to section 2.6.4(2)(g)	<b>\$43.70</b>

\* There may be an additional cost for a Criminal Record Check.

\*\* Annual registration fee is payable where registration is not due for renewal.

In all other cases the renewal fee applies.
