Amendment C263 (Part 1)

The Minister for Planning has approved Amendment C263 (Part 1) to the Boroondara Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment applies the Heritage Overlay to 3 Wilson Street, Surrey Hills (HO743), 70 Riversdale Road, Hawthorn (HO744), and 15 Victor Avenue, Kew (HO745), on a permanent basis, and deletes the interim Heritage Overlay (HO664) from 70 Riversdale Road, Hawthorn.
