### MINISTERIAL DIRECTION

I, Hon. Richard Wynne MP, Minister for Planning, amend the Ministerial Direction on the Form and Content of Planning Schemes prepared under section 7(5) of the **Planning and Environment Act 1987**, as follows:

1. Replace paragraphs 3, 10, 11, 15, 16, 17, 18, 20 and 21 with new paragraphs 3, 10, 11, 15, 16, 17, 18, 20 and 21 in the **Front Page**.
2. Replace the two tables after paragraph 6 with two new tables in the **Front Page**.
3. Replace the table after paragraph 15 with a new table in the **Front Page**.
4. Insert new paragraphs 24, 25 and 26 in the **Front Page**.
5. In Annexure 2 to the Direction:
  - i. Delete the template schedules to Clauses 52.01, 52.03, 52.37, 52.43, 52.44, 52.48, 57.01, 61.01, 61.02, 61.03 and 61.04.
  - ii. Insert the new template schedules to Clauses 45.12, 51.01, 51.02, 51.03, 51.04, 51.05, 52.12, 52.33, 53.01, 53.06, 53.15, 59.15, 59.16, 72.01, 72.02, 72.03, 72.04, 72.05, 72.08, 74.01 and 74.02.
  - iii. Replace the template schedules to Clauses 32.04, 36.02, 36.03, 37.01, 37.02, 37.03, 37.04, 37.05, 37.06, 37.07, 37.08, 42.01, 42.02, 42.03, 43.01, 43.02, 43.03, 43.04, 44.01, 44.02, 44.03, 44.04, 44.05, 44.06, 45.08, 45.09, 52.05, 52.17 and 52.28 with the new schedules to those clauses.
6. Replace Annexure 3 to the Direction with a new Annexure 3.
7. Replace Annexure 4 to the Direction with a new Annexure 4.

### STRATEGIC ASSESSMENT OF AMENDMENTS

  - ‘● If the planning scheme includes a Local Planning Policy Framework, how does the amendment support or implement the Local Planning Policy Framework, and specifically the Municipal Strategic Statement?’.
3. After the seventh bullet point item in paragraph 3(1) of the Direction **insert** –
  - ‘● If the planning scheme includes a Municipal Planning Strategy, how does the amendment support or implement the Municipal Planning Strategy?’.

I, Hon. Richard Wynne MP, Minister for Planning, amend Direction No. 13, Managing Coastal Hazards and the Coastal Impacts of Climate Change, prepared under section 12(2)(a) of the **Planning and Environment Act 1987**, as follows:

1. For the first bullet point item under the heading ‘Requirements to be met’ **substitute** –
  - ‘● Is consistent with the planning policies, objectives and strategies for coastal Victoria as outlined in state planning policies (including regional planning policies) in the Planning Policy Framework.’.
2. For the last bullet point item under the heading ‘Requirements to be met’ **substitute** –
  - ‘● Considers the views of the relevant floodplain manager and relevant Victorian Government department.’.
