Payroll Tax Act 2007

DECLARATION OF APPROVED GROUP TRAINING ORGANISATIONS

1 Purpose

The purpose of this Declaration is to declare certain organisations to be approved group training organisations for the purpose of Division 1, Part 3 of Schedule 2 to the **Payroll Tax Act 2007**.

2 Authorising provision

This notice is made under clause 13B(1) of Schedule 2 to the **Payroll Tax Act 2007**. Clause 13B(1) provides that the Treasurer, by notice published in the Government Gazette, may declare an organisation to be an approved group training organisation for the purposes of Division 1, Part 3 of Schedule 2 to the **Payroll Tax Act 2007**.

3 Revocation

The Declaration dated 23 February 2009 and gazetted on 5 March 2009 declaring approved group training organisations for the purpose of the **Payroll Tax Act 2007** is revoked with effect from 1 July 2016.

4 Declaration

I, Tim Pallas, Treasurer of the State of Victoria, being the Minister responsible for administering the **Payroll Tax Act 2007**, do hereby declare for the purpose of clause 13B of Schedule 2 to the **Payroll Tax Act 2007** –
