## Meat Industry Act 1993

### LEGISLATIVE INSTRUMENT DETERMINING CATEGORIES AND FIXING FEES FOR GAME MEAT PROCESSING FACILITY LICENCES

- 1) Pursuant to subsections 14(2)(b), 44(f), 44(h) and 45(2)(b) of the **Meat Industry Act 1993**, PrimeSafe, being the Authority established under Part 6 of that Act –
  - a) Revokes the category of licence known as ‘Game Meat’ (described in the Instrument: ‘Legislative Instrument Determining Licence Categories and Fixing Fees for Meat Processing Licences’ published in the Victoria Government Gazette Number S139 on 3 May 2017 at page 2; and
  - b) Determines the categories of licences listed in Column 1 of the Table; and
  - c) Fixes, for the period commencing from the day this instrument comes into operation up to 30 June 2019, for each category of licence specified in Column 1 of the Table, the application fee listed in Column 3 and the annual fee listed in Column 4 of the Table, based, as applicable, on the annual throughput specified in Column 2, subject to the following exception:
    - i) any application fee specified in Column 3 is only payable for the initial application for a category of game meat processing facility licence.
- 2) In this instrument, annual throughput means the weight (in tonnes) of game carcasses or game meat brought into the relevant facility for processing (including storage) in the licensing period to which the licence will apply.
- 3) This instrument is effective from the date it is published in the Victoria Government Gazette.

**Meat Industry Act 1993****LEGISLATIVE INSTRUMENT FIXING FEES FOR APPROVAL OF  
GAME MEAT FIELD HARVESTERS**

- 1) Pursuant to section 44(h), 44(i) and 45(2)(b) of the **Meat Industry Act 1993** (the Act), and regulation 35A of the Meat Industry Regulations 2015 (the Regulations), PrimeSafe, being the Authority established under Part 6 of the Act, fixes, for the period commencing from the day this instrument comes into operation up to 30 June 2019 –
- a) the application fee specified in Column 2 for the initial application for an approval under regulation 35A of the Regulations; and
  - b) the annual fee listed in Column 3 for any approval under regulation 35A of the Regulations, including the initial approval.
- 2) This instrument is effective from the date it is published in the Victoria Government Gazette.
