Notice of Approval of Amendment
Amendment GC103

The Minister for Planning has approved Amendment GC103 to the Cardinia, Casey, Greater Dandenong, Monash and Stonnington Planning Schemes.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment inserts Clause 45.12 (Specific Controls Overlay) and a new Schedule 1 to Clause 45.12, inserts the *Monash Freeway Upgrade Project (Stage 2) Incorporated Document, August 2018* into the schedules to Clause 45.12, amends the Schedule to Clause 72.03 (What does this Scheme consist of?), and the Schedule to Clause 72.04 (Documents incorporated in this planning scheme) of the Cardinia, Casey, Greater Dandenong, Monash and Stonnington Planning Schemes.

The Amendment also applies the Public Acquisition Overlay (PAO) to identify land proposed to be acquired by the Roads Corporation for the purposes of the project in the Cardinia Planning Scheme. The Amendment also amends and applies the existing PAO over the land required for the O'Shea Road upgrade and extension in the Casey Planning Scheme.

The Amendment also rezones land declared under the **Road Management Act 2004** to Road Zone – Category 1 in the Greater Dandenong Planning Scheme.
