ROAD DECLARATIONS

ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice revokes and declares the roads described in Schedule A and on the plans attached.

VicRoads also authorises the freeway access points described in Schedule B and on the plans attached.

The effects of these Road Declarations on road names are described in Table 1.

SCHEDULE A

FREEWAY

- a) Those parts of Princes Freeway identified by hatching on the plans numbered GP23677 and GP23677A are revoked and declared as described in the legend in the said plans.

ARTERIAL ROAD

- b) Those parts of High Street identified by hatching on the plan numbered GP18533A are declared as described in the legend in the said plan.
- c) Those parts of Koo-Wee-Rup–Longwarry Road identified by hatching on the plan numbered GP23677B are declared as described in the legend in the said plan.
