Marine Safety Act 2010 Section 185

CONSEQUENTIAL RULE

I, Rachel Gualano, Director Maritime Safety (as delegate of the Director, Transport Safety) make the following consequential rule under section 185 of the **Marine Safety Act 2010** which is consequential to the making of the waterway rule below.

1. SCHEDULE 104: In line 48, of column 2 of the table: Actual Location (GDA 94) remove 147.949491 and replace with 147.949492.
2. SCHEDULE 104: In line 49, column 2 of the table: Actual Location (GDA 94) remove 147.950648 and replace with 147.949497.

Marine Safety Act 2010 Section 184

WATERWAY RULE

I, Rachel Gualano, Director Maritime Safety (as delegate of the Director, Transport Safety) make the following waterway rule under section 184 of the **Marine Safety Act 2010**.

SCHEDULE 104

Waters – The Local Port of Gippsland Lakes

Waterway Manager – Gippsland Ports Committee of Management Inc.

After Clause 104.2(t) and before Clause 104.2(u) insert:

- (i) All the waters of Hopetoun Channel bounded on the west by a line east of Barrier Landing, joining a 5 knot sign on the south shore⁴⁹ and a 5 knot sign on the north shore⁴⁸, then east to a 5 knot sign on the southern shore⁴⁰ 460 m west of the inner end of the Western Entrance Wall and then to a 5 knot sign on the opposite shore⁴¹, shall during the period commencing one hour before sunrise and ending one hour after sunset have a speed restriction of 5 knots.
