
Surf Coast Shire Council (Council), at its meeting of 26 June 2018, resolved to proceed with the road deviation and land exchange of the portions of Palmer Street and Main Streets, Winchelsea, pursuant to section 207B Clauses 2 of Schedule 10 of the **Local Government Act 1989** (the Act), in accordance with the accompanying plan.

Under Clause 2(2) of Schedule 10 of the Act, consent was obtained on 9 January 2019 from the Minister for Energy, Environment and Climate Change, as the responsible Minister administering the **Land Act 1958** (under delegated authority), to the proposed road deviation as shown on the accompanying plan.

Council, at its meeting on 26 June 2018, authorised Council officers to proceed with the gazettal and land exchange in the event that no written submissions were received within the prescribed timeframe.

No written submissions were received by Council in accordance with section 223 of the Act, now gives effect under Schedule 10, Clause 2(3) of the Act to the road deviation in accordance with the plan.


Following the vesting, the discontinued section of road labelled A (cross-hatched) will be transferred to the adjoining land owner. Labelled area B (hatched) will become road owned by Council.

 Notice of the Preparation of an Amendment
 Amendment C167

The Darebin City Council has prepared Amendment C167 to the Darebin Planning Scheme. The land affected by the Amendment is as listed and highlighted on the map:

- 22–50 Showers Street, Preston
- 19–49 Showers Street, Preston



The Amendment proposes to implement the ‘Showers Street Design Guidelines – Background Report (2018)’ as a reference document into the Planning Scheme by introducing a new Design and Development Overlay for Showers Street and altering the existing Design and Development Overlay and Development Plan Overlays.

You may inspect the Amendment, any documents that support the Amendment and the explanatory report about the Amendment, free of charge, at the following locations: during office hours, at the office of the planning authority, Darebin City Council, Level 1, 274 Gower Street, Preston; at the Department of Environment, Land, Water and Planning website, www.delwp.vic.gov.au/public-inspection; and during opening hours at the Preston Library, 266 Gower Street, Preston.

Any person who may be affected by the Amendment may make a submission to the planning authority about the Amendment. 
