

Amendment C138

Mitchell Shire Council has prepared Amendment C138 to the Mitchell Planning Scheme.

The Amendment proposes to rezone part of the land at 49 Emily Street and 17 High Street, Seymour, from General Residential 1 Zone (GRZ1) to Commercial 2 Zone (C2Z).

EXEMPTION

Application No. H355/2018

Women's Health and Wellbeing Barwon South West (the Applicant) has applied to the Victorian Civil and Administrative Tribunal for an exemption to enable it to:

- (a) advertise for and employ only women;
- (b) provide a service for only women; and
- (c) restrict membership of the organisation to individuals who are women.

Upon reading the material filed in support of this application, including the affidavit by Acting CEO, Justine Devonport, submissions made by the Applicant's CEO, Emma Mahoney, at a hearing and having regard to an earlier exemption which expired on 15 June 2014, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 18, 44, 107 and 182 of the **Equal Opportunity Act 2010** (the Act) to enable the Applicant to engage in the following exempt conduct until 28 March 2024:

- (a) advertise for and employ only women;
- (b) advertise for only women board members; and
- (c) provide a service for only women (together, the exempt conduct).

In granting this exemption the Tribunal noted:

- The Applicant's Statement of Purpose includes maintaining a rural and regional women's health organisation that is run by women for women, with the overall objective of improving women's health. The organisation seeks to increase health equity by involving and consulting with women to reflect the needs of women in Barwon South West Region.
- The Applicant is funded by the Victorian Department of Health and Human Services to provide health and wellbeing services for women.
- The Applicant's board has nine female members from across the Barwon South West region responsible for governance of the Applicant organisation. The board meets monthly. Board members do not receive fees for their service, however necessary expenses are reimbursed. As membership of the board is voluntary and the Applicant is not a club within the definition in the Act, there are no relevant areas of discrimination from which to exempt the conduct of the restriction of board membership to females. There is a possibility that advertising for only women board members might attract coverage under the Act. Accordingly, the exemption granted differs from the conduct noted in the application to this extent.
- I am satisfied that the conduct does not constitute a special measure given that the conduct applies to all administrative and governance roles within the organisation as well as the direct service provision to women.
- When making decisions about exemptions, the Tribunal is required to consider relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and the right to equal and effective protection against discrimination of males who would wish to be employed or receive services

from the Applicant. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an interim exemption from the operation of sections 16, 18, 44, 107 and 182 of the **Equal Opportunity Act 2010** to enable the Applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which the notice is published in the Government Gazette until 28 March 2024.
