




Local Government Act 1989ROAD DISCONTINUANCE

Maribyrnong City Council (Council) has formed the opinion that the road abutting 141 and 149 Somerville Road and 193 and 195 Williamstown Road, Yarraville, shown hatched on the plan below, being the road contained in Certificate of Title Volume 2556 Folio 109, is not reasonably required as a road for public use. Council resolved on 30 April 2019 acting under Clause 3 of Schedule 10 and sections 206 and 207B of the **Local Government Act 1989**, to discontinue the road and to sell the discontinued road to the abutting owners of 141 Somerville Road and 195 Williamstown Road, Yarraville.

Kyneton Airfield Local Law No. 12 of 2018

Local Government Act 1989 – Section 119(3)

Pursuant to section 119(3) of the **Local Government Act 1989**, Macedon Ranges Shire Council, at its meeting on Wednesday 27 March 2019 resolved to make the Kyneton Airfield Local Law No. 12 of 2018.

Purpose of the Kyneton Airfield Local Law No. 12 of 2018

The objectives of this Local Law are to provide for the peace order and good government of the Macedon Ranges Shire by:

- (a) Implementing interim measures to assist with the safe operation of the Kyneton Airfield;
- (b) regulating and controlling potential hazards that could be a risk to the community and the safe operation of the Airfield; and
- (c) applying controls which will complement other measures being applied by the Council to assist with the safe operation of the Airfield which is an unregistered Airfield.

General Purport of the Local Law

The Local Law will achieve its purposes by a number of measures including:

- Managing hazards in the vicinity of the airfield by not permitting or allowing an owner or occupier of land to cause a use, activity or condition, whether man-made or natural to be or become a hazard to the safe operation of aircraft using the airfield;
- Identify hazards which have been classified as:
 - (a) a structure, including a pole, antenna or radio mast penetrating the OLS;
 - (b) a tree that is penetrating or is likely to penetrate the OLS because of further growth in a short period;
 - (c) a vehicle, including a crane or height extension apparatus penetrating the OLS;
 - (d) a light which can cause glare, confusion or generally interferes with the operation of aircraft or is likely to endanger the safety of aircraft;
 - (e) waste or other materials which attracts birds and is likely to constitute an attraction to birds so as to create a hazard or potential hazard to aircraft using or operating in the vicinity of the Airfield.
- Applying systems for the notification of hazards and the subsequent risk reduction strategies that must be adhered to by owners, occupiers or business operators.

- a. Part 2 contains provisions which aim to protect the amenity of public places for all citizens by controlling behaviour in public places and by prohibiting persons from causing damage to public places or acting in a socially unacceptable manner.
- b. Part 3 aims to provide for the responsible management of public places (including the control of the consumption of liquor), so as to enhance the enjoyment of them by the general public, especially during major events.
- c. Part 3A aims to provide for the responsible management of public places so as to enhance the enjoyment of them by the general public by prohibiting smoking tobacco products in smoke free areas within the municipality.
- d. Part 3B aims to provide for the responsible care and management of animals within the municipality including regulating the number and types of animals a person may keep without a permit.
- e. Part 10 contains provisions which aim to ensure that the appearance of buildings in the municipality are consistent with an image of the municipality that is safe, attractive and well maintained by controlling premises that have been allowed to reach a dilapidated, unsightly or dangerous condition.
- 1. Part 11 contains provisions to provide for the making of clear signage of road names and street numbers to assist in the management of the municipality and assist emergency services.
- m. Part 12 contains provisions that aim to regulate and prohibit activities in public places not elsewhere covered by the Local Law to improve the amenity of the municipality and to protect other assets of the Council (such as pedestrian service signs).

EXEMPTION

Application No. H68/2019

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by the Ocean Grove Bowling Club Inc. (the applicant). The application for exemption is to enable the applicant to organise, operate and advertise the specified bowling tournaments in which participation is to be limited to men-only or women-only (the exempt conduct). The specified bowling tournaments are as follows:

- 1. Women only tournaments:
 - a. Ocean Grove Open Day
 - b. Ocean Grove Classic
 - c. Monthly Monday Triples
 - d. Women's Club Championships singles, pairs, triples, 21 Up, 100 up, veterans, minors.
- 2. Men only tournaments:
 - Ocean Grove Classic
 - b. Monthly Thursday Triples
 - c. Men's Club Championships singles, pairs, triples, 21 Up, 100 up, veterans, minors.

Upon reading the material filed in support of this application, including the affidavit of Margaret Carroll, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 44, 71, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- A copy of the application was sent by the Tribunal to the Victorian Equal Opportunity and Human Rights Commission (the Commission). The Commission did not seek leave to intervene in the proceeding. The applicant has been a registered bowling club since 1953. Currently, just over 86% of its bowls events are mixed. That is a slightly higher percentage than when the previous exemption was granted in 2014. However, a core of members remain who do not wish to participate in mixed competitions and would not participate at all except for the remaining single sex events. The applicant club states that it aims to provide a level playing field and believes this is best achieved by offering a broad range of single gender and mixed events for members to participate and enjoy. Both mixed gender and single gender events are spread over the week.
- Many of the above tournaments are longstanding. The women-only Ocean Grove Classic commenced some forty years ago. Some of the women-only club events noted in item d. above commenced in 1954. The men's events are also longstanding. The Ocean Grove Classic commenced in 1986. The Monthly Triples began over thirty years ago. Some of the men-only club events noted in item c. commenced in 1954. Trophies and honour boards recording the results and naming successful participants over the years are kept in a prominent position and the applicant club is proud of its traditions.
- No exception or current exemption already applies to the exempt conduct and in the absence of an exemption the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the Charter of Human Rights and Responsibilities Act 2006 (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of men or women who would wish to play in an event limited to another gender. In the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 44, 71, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 9 May 2024.



THE AUSTRALIAN COMPUTER SOCIETY PROFESSIONAL STANDARDS SCHEME

PREAMBLE

- A. The Australian Computer Society Inc (ACS) is an occupational association.
- B. The ACS has made an application to the Professional Standards Council, appointed under the **Professional Standards Act 1994** (NSW) (the Act), for the approval of a scheme under the Act as set out in this document.
- C. The scheme is prepared by the ACS for the purposes of limiting occupational liability to the extent to which such liability may be limited under the Act.

- F. The scheme is intended to commence in New South Wales on 1 January 2019 and remain in force for five (5) years from its commencement unless, prior to that time, it is revoked, its operation ceases, or it is extended pursuant to the applicable legislation of the relevant jurisdiction.
- G. Unless otherwise defined in this scheme, terms used in the scheme have the meaning given in the Act.
- H. The scheme is intended to apply in all states and territories of Australia.

THE AUSTRALIAN COMPUTER SOCIETY PROFESSIONAL STANDARDS SCHEME

1 Occupational association

1.1 The Australian Computer Society Professional Standards Scheme (the scheme) is a scheme under the Act prepared by the Australian Computer Society Inc (ACS) whose national office address is Tower One, International Towers, 100 Barangaroo Avenue, Sydney, New South Wales 2000.

2 Persons to Whom the Scheme Applies

- 2.1 The scheme will apply to ACS members who are Certified Professional Members. A Certified Professional Member is defined as a member of ACS with a current 'Certified Professional' certification from ACS. 4 Limitation of liability

- 4.1 This scheme only affects the liability for damages arising from a single cause of action to the extent to which the liability results in damages exceeding \$2,000,000.
- 4.2 This scheme limits the occupational liability in respect of a cause of action founded on an act or omission occurring during the period when the scheme was in force of any person to whom the scheme applied at the time the act or omission occurred.
- 4.3 If a person, who was at the time of the act or omission giving rise to occupational liability, a person to whom the scheme applied and against whom a proceeding relating to occupational liability is brought, is able to satisfy the court that such person has the benefit of an insurance policy:
 - (a) of a kind which complies with the standards determined by the ACS;
 - (b) insuring such person against that occupational liability; and
 - (c) under which the amount payable in respect of that occupational liability is not less than the monetary ceiling specified in this scheme,

that person is not liable in damages in relation to that cause of action above the monetary ceiling specified in this scheme.

- 4.4 The monetary ceiling is \$2.0 million.
- 4.5 Clause 4.3 only affects liability for damages arising from a single cause of action to the extent to which the liability results in damages exceeding the amount of damages specified in clause 4.1.
- 4.6 Notwithstanding anything to the contrary contained in this scheme if, in particular circumstances giving rise to occupational liability, the liability of any person who is subject to this scheme is capped both by this scheme and also by any other scheme under professional standards legislation (whether of this jurisdiction or under the corresponding law of any other Australian state or territory) and, if the amount of such caps should differ, then the cap on the liability of such person arising from such circumstances which is higher shall be the applicable cap.

5 Discretionary authority

5.1 This scheme confers on the ACS a discretionary authority to specify, on application by a person to whom the scheme applies, in relation to that person, a higher maximum amount of liability not exceeding \$10 million, in relation to that person either in all cases or in any specified case or class of case.

6 Duration

- 6.1 This scheme will commence in New South Wales, the Northern Territory, Tasmania, Western Australia, Victoria and Queensland on 1 January 2019.
- 6.2 In the Australian Capital Territory and in South Australia, the scheme will commence:
 - (a) on the date provided for in the Minister's notice in relation to the scheme, if a date is provided; or
 - (b) on the first day two months after the day on which notice was given, in any other case.
- 6.3 This scheme will be in force in New South Wales for five years from the date of commencement in that jurisdiction.

- 6.4 For any other jurisdiction, the scheme will be in force for:
 - (a) 5 years from the date of commencement in that jurisdiction; or
 - (b) 5 years from the date of commencement in New South Wales; whichever period ends first.
- 6.5 Clauses 6.3 and 6.4 are subject to the provisions of each jurisdiction applicable to the revocation, extension or cessation of schemes.
