ROAD SAFETY ROAD RULES 2017

Specification of Electric Personal Transporter Use Area – Lakes Entrance

1. Purpose

The purpose of this notice is to specify an area encompassing roads and road related areas to be an electric personal transporter use area.

2. Background

Rule 244D of the *Road Safety Road Rules 2017* provides that it is an offence for a person to travel on an electric personal transporter on a road or road related area unless the person is taking part in an electric personal transporter tour on an electric personal transporter supplied to the person as part of that tour.

Rule 244E of the *Road Safety Road Rules 2017* provides that a person must not travel on an electric personal transporter on a road or a road related area unless that road or road related area is an electric personal transporter route or in an electric personal transporter use area.

Rule 244C(1) of the *Road Safety Road Rules 2017* authorises the Roads Corporation, by notice published in the Victoria Government Gazette, to do either or both of the following –

- (a) specify a route consisting of specified roads and road related areas as an electric personal transporter route;
- (b) specify an area encompassing roads and road related areas to be an electric personal transporter use area.

Before the Roads Corporation publishes a notice under rule 244C(1), it must consult with any other road authority that the Corporation considers may be affected by that publication.

3. Authorising Provision

This notice is made under rule 244C(1) of the *Road Safety Road Rules 2017*.

4. Commencement

This notice comes into operation on the date that it is published in the Victoria Government Gazette.

5. Specification

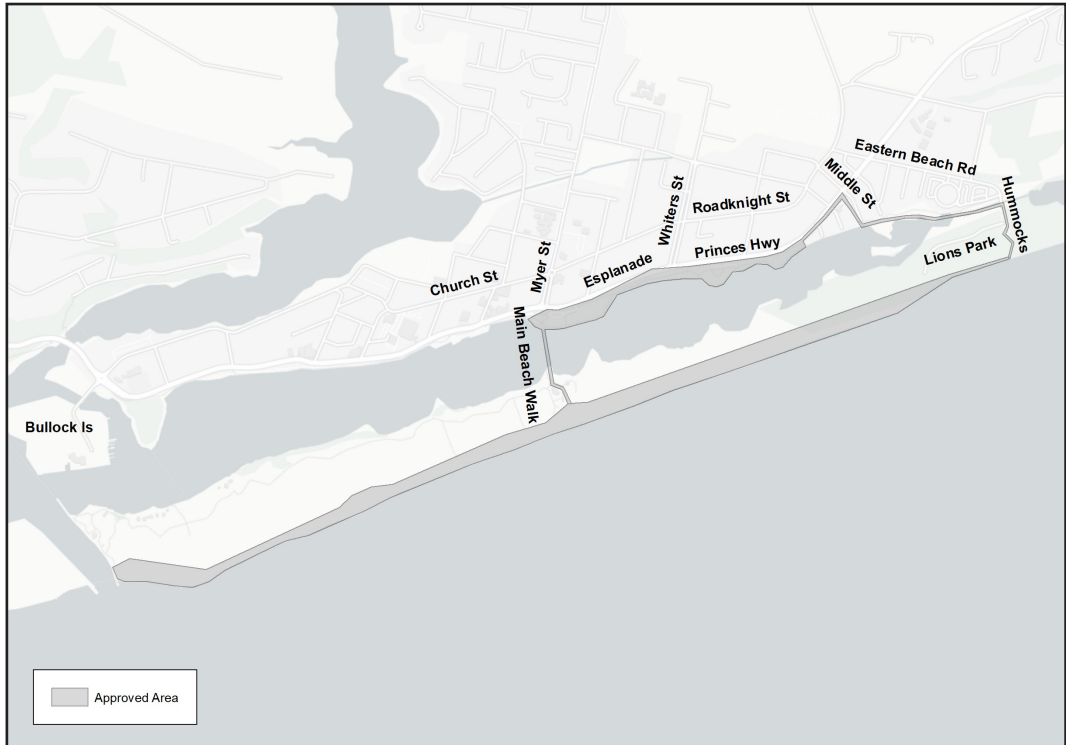
