## **Fundraising Act 1998** Section 16A(1)

### FUNDRAISING EXEMPTION ORDER

I, Marlene Kairouz, Minister for Consumer Affairs, Gaming and Liquor Regulation, make this Order under section 16A(1) of the **Fundraising Act 1998**.

#### **1. Objectives**

The objectives of this Order are:

- (a) to exempt persons and organisations from complying with parts of the **Fundraising Act 1998**; and
- (b) to revoke the previous Exemption Order made under section 16A of the **Fundraising Appeals Act 1998** published on 20 December 2001.

#### **2. Definitions**

In this Order:

**the Act** means the **Fundraising Act 1998**.

#### **3. Commencement**

This Order takes effect upon publication in the Gazette.

#### **4. Exemption from section 17A of the Fundraising Act 1998**

A person or organisation is exempt from section 17A of the Act if a person or organisation:

- (a) receives less than \$20,000 gross in a financial year from the conduct of fundraising appeals;
- (b) is not paid for the conduct of a fundraising appeal (except for the reimbursement of direct out-of-pocket-expenses); and
- (c) in the conduct of those fundraising appeals, only engages volunteers who are not paid (except for the reimbursement of direct out-of-pocket expenses).

#### **5. Exemption from Part 3 of the Fundraising Act 1998**

An organisation specified in this paragraph of this Order is exempt from compliance with Part 3 of the Act –

- (a) an organisation which is a licensee, or an approved provider of a children's service under the **Children's Services Act 1996** or an approved provider of an education and care service under the **Education and Care Services National Law Act 2010** of the Commonwealth and that receives funding for a kindergarten program from the Secretary to the Department of Education and Training;
- (b) Cancer Council Victoria.

#### **6. Revocation**

The Order made under section 16A of the **Fundraising Appeals Act 1998** commencing on 1 January 2002 and published in the Victorian Government Gazette No. 51 of 20 December 2001 is revoked.
