## Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES  
IN CITY OF GREATER GEELONG, GOLDEN PLAINS SHIRE AND  
WYNDHAM CITY COUNCIL FOR THE TAC FILMING ON TUESDAY 16 JULY 2019,  
WEDNESDAY 17 JULY 2019, THURSDAY 18 JULY 2019 AND FRIDAY 19 JULY 2019

### 1. Purpose

The purpose of this Declaration is to exempt participants in the TAC Filming from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 on Tuesday 16 July 2019, Wednesday 17 July 2019, Thursday 18 July 2019 and Friday 19 July 2019.

### 2. Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

### 3. Commencement

This notice takes effect at 7.00 am on Tuesday 16 July 2019, Wednesday 17 July 2019, Thursday 18 July 2019 and Friday 19 July 2019 or when Victoria Police declare the road closed.

### 4. Expiry

This notice expires at 11.59 pm on Tuesday 16 July 2019, Wednesday 17 July 2019, Thursday 18 July 2019 and Friday 19 July 2019 or when Victoria Police declare the road open.

### 5. Definitions

In this notice, unless the context or subject-matter otherwise requires –

- (a) ‘Event’ means the TAC Filming, to be held on Tuesday 16 July 2019, Wednesday 17 July 2019, Thursday 18 July 2019 and Friday 19 July 2019; and
- (b) ‘Participants’ means participants in the Event, including officers, members and authorised agents of the Finch Company, whose presence is reasonably required to ensure the safe conduct of the Event.

### 6. Declaration

I, Paul Northey, as delegate of the Minister for Roads and Road Safety, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by Department of Transport and the municipal council.
