NOTICE CONTROLLING NAVIGATION IN THE VICINITY OF WORKS

Parks Victoria, as the declared waterway manager for the waters of the Yarra River upstream of port waters of the Port of Melbourne makes the following notice under section 211(1)(b)(i) of the **Marine Safety Act 2010** (the Act).

For the purposes of the works activity proposed by HQ Group for mobilisation and construction of floating restaurant infrastructure on the Yarra River, navigation and movement of vessels is prohibited in the waters of the Yarra River as detailed below, excluding vessels involved in the works and Parks Victoria vessels.

- **Loading zone waters – from 9.30 am to 3.30 pm each day:**
Waters southern side of the Yarra River immediately downstream of VRA Landing and upstream of Princes Bridge, 50 metres wide and extending 20 metres from the river bank.
- **Installation zone waters – all times for the duration of the works:**
Waters northern side of the Yarra River downstream of Princes Bridge and upstream of Evan Walker Bridge, 30 metres upstream and downstream of the pontoon and extending 25 metres from the river bank.

The prohibited waters will be marked by lit yellow exclusion zone buoys and line barrier buoys.

Vessel operators are advised to operate with extreme caution when transiting between the loading zone and the construction zone, due to the increased waterway traffic and restricted visibility and manoeuvrability of the works vessels.

This notice has effect for the duration of the works from 7.00 am Wednesday 28 August to 5.00 pm Thursday 5 September 2019.

Times and dates are subject to change. Changes to time, duration or days will be advertised on the Parks Victoria website and in a Notice to River Users (NTRU).
