MINISTERIAL ORDER NO. 1267

Order Amending Ministerial Order No. 1038 – Teaching Service (Employment Conditions, Salaries, Allowances, Selection and Conduct)

The Minister for Education makes the following Order –

**1. Title**

This Order may be cited as Ministerial Order No. 1267 – *Order Amending Ministerial Order No. 1038 – Teaching Service (Employment Conditions, Salaries, Allowances, Selection and Conduct)*.

**2. Purpose**

This Order amends Ministerial Order No. 1038 – *Teaching Service (Employment Conditions, Salaries, Allowances, Selection and Conduct)* (Ministerial Order No. 1038) to:

- (a) substitute clause 2.7.3(1), concerning the Secretary’s power to determine salary, to allow for an additional salary to be payable that is not subject to the maximum salary specified in schedule 1.

**3. Authorising provision**

I make this Order, in respect of employment in the Teaching Service under Part 2.4 of the **Education and Training Reform Act 2006** (the Act), under sections 5.10.4 and 5.10.5 of the Act and item 8 of Schedule 6 to the Act.

**4. Commencement**

This Order is made on the date it is signed and commences in accordance with its terms.

**5. Amendment to Part 2**

In clause 2.7.3(1) of Ministerial Order 1038, **substitute** –

- ‘(1) (a) Notwithstanding Divisions 1, 2, 3, 4 and 5 of this Part the Secretary may determine the salary (including any salary in addition to the salary determined under Divisions 1, 2, 3, 4 and 5) for any employee for whose circumstances no provision is made in this Part;
- (b) Where the Secretary makes a determination under subclause (a), the employee’s total salary must not be less than the salary determined under Divisions 1, 2, 3, 4 and 5 of this Part and may exceed the maximum salary specified in schedule 1 for the relevant salary range of the employee.’
