Pursuant to sections 35 and 39 of the **Electricity Industry Act 2000**, the following rates for Deemed and Standing offer domestic and small business customers apply effective 1 January 2020 until such time as tariffs are varied. The Victorian Default Offer in respect of flat tariffs have been varied due to the 'Victorian Default Offer Price Determination 2020' made by the Essential Services Commission. All other Standing offer tariffs have been varied due to the introduction of the Victorian Default Offer in respect of the VDO compliant maximum annual bill. The weighted average tariff variation for affected electricity customers is an increase of 15.7%.
