DECLARATION OF BOATING ACTIVITY EXEMPTION

Latrobe City Council, as the declared waterway manager for Lake Narracan, makes the following declaration under section 203(3) of the **Marine Safety Act 2010**.

For the purposes of boating activity conducted by Latrobe Valley Water Ski Club on 17 to 19 January 2020 at Lake Narracan, persons and vessels involved in the activity are exempt from the following requirements:

State Rules made under the Marine Act 1988

1. Clause 3(a) – 5 knots within 50 metres of the water's edge;
2. Clause 3(b) – 5 knots within 50 metres of a fixed or floating structure;

Marine Safety Regulations 2012

3. Regulation 103 – person being towed must wear a PFD at all times;
4. Regulation 104(2) – Master must not tow a person unless the person is wearing a PFD.

Subject to the conditions detailed below:

- Master of rescue vessels are only exempt from items 1 and 2 when undertaking rescue responsibilities to retrieve persons in distress, provide for their initial medical or other needs and deliver them to a place of safety on shore.
- Water skiers are only exempt from item 3 when participating in trick skiing activities.

DECLARATION OF BOATING ACTIVITY EXEMPTION

Swan Hill Rural City Council as the declared waterway manager for Lake Boga, makes the following declaration under section 203(3) of the **Marine Safety Act 2010**.

For boating activity conducted by Victorian Speed Boat Club, persons and vessels involved in the Victorian Speed Boat Club Gold Cup are exempt from the following requirements:

State Rules made under the Marine Act 1988

1. Clause 2(a) – 5 knots within 50 metres of a person in the water;
2. Clause 2(c) – 5 knots within 50 metres of another vessel;
3. Clause 3(a) – 5 knots within 50 metres of the water's edge and

Marine Safety Regulations 2012

4. Regulation 44(2)(b) – holders of Restricted Marine Licences to operate a vessel at a speed not exceeding 10 knots.

Subject to the conditions detailed below:

- Masters of rescue vessels are only exempt from the above Items 1, 2 and 3 when undertaking a rescue operation to retrieve persons in distress, provide for their initial medical or other needs and deliver them to a place of safety onshore.
- Masters of competing vessels are only exempt from the above Items 2 and 3 for the duration of the event.
- Masters of Formula Future class vessels holding a Restricted Marine Licence are only exempt from Item 4 provided they have completed the training required by APBA Victoria as detailed in the Formula Future Safety Management Plan and hold the appropriate APBA Formula Future licence, and must not exceed the following speeds:
 - i. J1 class – 19 knots
 - ii. J2 class – 33 knots
 - iii. J3 class – 40 knots.
- Occupants of rescue and Official vessels are always to wear PFDs and must have all the prescribed safety equipment.
- Occupants of competing vessels must wear PFDs that comply with 2019–20 APBA Rule book Revision No. 1.0.
- All interstate vessel masters in Formula Future classes must hold the appropriate APBA Formula Future licence and have documented proof they have competed in at least 3 events (9 races) in their home state before competing at an event in Victoria. Should they not provide this proof they must complete the training required by APBA Victoria as detailed in the Formula Future Safety Management Plan.
- In the event of any injuries which result in hospitalisation, a fatality or an incident involving a person or vessel not involved in the event, these must be immediately reported to MSV and Victorian Police. In the case of all other incidents, MSV requires incident reports within seven days and a finalised report within 30 days. This requirement will be detailed in the declaration per section 207(2) of the MSA.

- The exemptions apply from 7.00 am to 7.00 pm, on Saturday 11 January 2020 with a backup date of 12 January 2020 (weather dependent), within the exclusion zone waters of Lake Boga.
- The exemptions and modification apply provided the stated safety controls and undertakings detailed in the application form and associated documentation are adhered to.
