I, Aaron de Rozario, Chief Executive Officer of the Commercial Passenger Vehicle Commission, acting under delegation and pursuant to regulation 11(1) of the Commercial Passenger Vehicle Industry Regulations 2018, hereby determine that the specifications in this instrument apply to wheelchair accessible commercial passenger vehicles under the **Commercial Passenger Vehicle Industry Act 2017** and its Regulations as wheelchair accessible commercial passenger vehicles, on and from the date that this instrument is published in the Government Gazette.

2. The specifications in this instrument supersede those set out in the Determination of Specifications for Wheelchair Accessible Commercial Passenger Vehicles as published in the Victoria Government Gazette on 29 June 2018.
3. To the extent of any inconsistency between these Specifications and the Australian Design Rules administered by the Commonwealth Government under the **Motor Vehicle Standards Act 1989** (Cth) as in force from time to time, the Australian Design Rules prevail over these Specifications.

SPECIFICATIONS FOR WHEELCHAIR ACCESSIBLE COMMERCIAL PASSENGER VEHICLES

1. Accommodation Space and Access Doorway

A wheelchair accessible commercial passenger vehicle (WAV) used to provide a commercial passenger vehicle service must:

- 1.1 contain a rectangular space for each wheelchair proposed to be carried, that is not less than 1300 mm (length) x 800 mm (width) x 1500 mm (high)
- 1.2 have no intrusions into that space, except for adjustable restraint devices
- 1.3 have an access doorway with an unobstructed vertical height of at least 1500 mm
- 1.4 have an access doorway with an unobstructed width of at least 800 mm.

2. Wheelchair/Occupant Restraint Systems

- 2.1 Each wheelchair position must be fitted with:
 - an occupant restraint system (seat belts); and
 - a wheelchair restraint system.
- 2.2 Seat belts must be a:
 - lap **and** sash emergency locking retractor type; or
 - lap **and** harness type assembly.

Note:

A lap only seat belt **is not** a compliant restraint system for people in wheelchairs.

- 2.3 Wheelchairs must be secured to the WAV using at least four (4) tie-down points.
- 2.4 All restraints must be free from fraying, tears and knots.
- 2.5 All restraints must be installed to ensure a universal correct fitting and comply with the applicable Australian/New Zealand standards, including:
 - i. *AS/NZS 10542 Parts 1 & 2 Wheelchair tie down and occupant-restraint systems*; and
 - ii. any requirements contained in *AS2942 – 1994/Amendment 1-1998 Wheelchair Occupant Restraint Assemblies for Motor Vehicles* which are not covered in *AS/NZS 10542 Parts 1 & 2* must also be complied with.

3. Hoists and Ramps

- 3.1 Hoists fitted to the WAV must:
 - i. be securely mounted to the vehicle;
 - ii. have a skid resistant loading surface;
 - iii. have approach edges with an outer roll stop that is effective when the hoist is raised off the ground; and
 - iv. not have a vertical distance exceeding 12 mm between the horizontal surface of the hoist platform, in its fully raised position and the horizontal surface of the vehicle entrance (i.e. at floor level).

- 3.2 Any ramp fitted to a WAV when commencing service, must have a gradient (slope) no steeper than 1 in 6 and a width of no less than 800 mm.
- 3.3 Hoists and ramps must comply with the applicable Australian/New Zealand Standards, including *AS 3856 – Hoists and Ramps for people with disabilities – Vehicle mounted; Parts 1 & 2*.

4. General

- 4.1 An approval certificate issued by an engineer who is a signatory to the Vehicle Assessment Signatory Scheme (VASS) administered by VicRoads, must be presented to show that a modified vehicle meets the relevant standards for registration, if
- (a) modifications are carried out that could adversely affect:
 - (i) the structural integrity of the vehicle, such as major body or chassis modifications;
 - (ii) the vehicle's handling characteristics;
 - (iii) any primary safety system, such as steering system modifications; or
 - (b) modifications are carried out that affect the vehicles compliance with the standards for registration;
 - (c) seats are added or moved and seat belts are required for the additional or remaining seats; or
 - (d) child restraint anchorages are added to the vehicle.
- 4.2 Child restraint anchorages must be provided for at least two (2) forward-facing rear seating positions. Anchorages must be the clip type and compliant with applicable ADRs.
- 4.3 A fully maintained fire extinguisher of at least a 20B rating must be securely mounted in the WAV, and be readily available for use.
- 4.4 A fully operational air-conditioner/heater must be fitted in the vehicle to ensure adequate cooling and heating to occupants, including people in wheelchairs.
- 4.5 All equipment relevant to the operation of the WAV must be maintained in good working order.

2. Under section 14A(1A) of the Act, for the purposes of the above authorisation under section 13(1)(bb) of the Act, I approve:
 - (a) the health services listed in clause 5 of this approval as the health services in which the Schedule 2, 3, 4 and 8 poisons listed in the Primary Clinical Care Manual can be used, sold or supplied; and

- (b) that the clinical circumstances in which the Schedule 2, 3, 4 and 8 poisons are to be used, sold or supplied are as set out in the health management protocols within the Primary Clinical Care Manual.
3. For the purposes of the approvals in clauses 1 and 2, the 'Primary Clinical Care Manual' is the 10th edition 2019 of the Primary Clinical Care Manual authored by the State of Queensland (Queensland Health) and the Royal Flying Doctor Service (Queensland Section) and available at <http://www.health.qld.gov.au/pccm/>, as amended from time to time, including as published as any subsequent edition.
 4. This approval takes effect from the date of publication in the Victoria Government Gazette.
