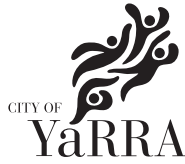

Amenity Local Law 2020

Notice is given, pursuant to section 119(3) of the **Local Government Act 1989** (the Act), that at its Ordinary Council meeting on 25 May 2020, Knox City Council (Council) resolved to make the *Amenity Local Law 2020* (the Local Law).

The following information about the Local Law is provided in accordance with section 119 of the Act:

The purpose of the Local Law is to:

- (a) Provide for the peace, order and good government of the municipal district; and
- (b) Promote a physical and social environment free from hazards to health, in which the residents of the municipal district can enjoy a quality of life that meets the general expectations of the community; and
- (c) Prevent and manage nuisances which may adversely affect the enjoyment of life within the municipal district or the health, safety and welfare of persons within the municipal district; and

to achieve these objectives by:

- (d) Regulating and managing activities of people within the municipal district which may be dangerous, unsafe or detrimental to the quality of life of other people in, or the environment of, the municipal district; and
- (e) Regulating and controlling the use and activity relating to Council land, roads and Council assets; and
- (f) Providing standards and conditions for specified activities to protect the safety and welfare of people within, and the environment of, the municipal district.

The general purport of the Local Law is as follows:

- Part 2: Private land and neighbourhood amenity – relates to the appearance and condition of private land and properties in the municipality, and includes properties that have been allowed to reach a dilapidated, unsightly or dangerous condition. This part also contains provisions to provide for clear signage of street numbers to assist in the management of the municipality and to assist emergency services.
- Part 3: Private land and the environment – contains provisions which aim to preserve the environment in the municipality, for a range of matters that are not already regulated for by other legislation.
- Part 4: Animals – contains provisions which aim to ensure that any animals kept on private land do not cause a nuisance or adverse impact on the amenity of the area.
- Part 5: Use of Council land and Roads – contains provisions to protect the amenity of Council land or roads through controls prohibiting persons from causing damage to, or acting in a socially unacceptable manner on Council land or roads.
- Part 6: Vehicles on Council land or Roads – contains provisions regarding the placement of vehicles on Council land or roads, for matters that are not already regulated for by other legislation.
- Part 7: Trading, fundraising and promotional activities on Council land or Roads – contains provisions relating to commercial, fundraising and promotional activities on Council Land and roads. This Part establishes a permit system to regulate these activities, and aims to enhance the appearance and safety of streets and public places by controlling the placement of items on Council land and roads. This Part contains provisions which aim to manage and facilitate responsible trading, entertainment and promotional activities on Council land and roads – to ensure the free passage and use of these areas by all users of these areas, and to maintain the amenity of the neighbourhood.
- Part 8: Alcohol and Smoking on Council Land and Roads – provides controls, related to the smoking of tobacco and consumption of alcohol, to achieve responsible management of Council land or roads so as to enhance the enjoyment of these areas by the community.
- Part 9: Council Assets, trees and regulating Building Sites – protects Council land and assets, including drains, vehicle crossings and Council trees and plants. These provisions establish a system of asset protection approvals, as a means of regulating building work which has potential to damage Council land or assets.

- Part 10: Permits – outlines the process for obtaining and retaining permits under the Local Law. This part also provides for the requiring a security bond if required by Council.
- Part 11: Compliance and enforcement of the Local Law – provides a means for enforcing this Local Law and powers to impound and serve Notices to Comply to seek compliance.
- Part 12: Delegations – provides for the delegation of Council’s powers, duties and functions under the Local Law to members of Council staff.

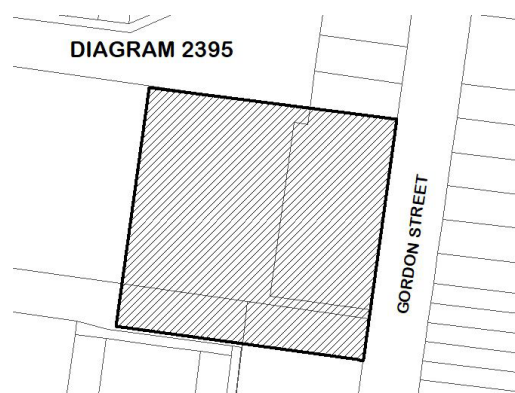

Electricity Safety Act 1998

EXEMPTION ORDER UNDER SECTION 120W OF THE ELECTRICITY SAFETY ACT 1998

Order in Council

The Governor in Council, under section 120W of the **Electricity Safety Act 1998** (Act), makes the following Order to exempt Powercor Australia Limited (ABN 89 064 651 109) (Powercor) from complying with section 120M of the Act on the terms and conditions specified in this Order.

1. EXEMPTIONS

Subject to Powercor's continued compliance with the conditions in clause 2 below, from the **effective date** of this Order, Powercor is exempt from the requirement to ensure that the following **zone substations** are **complying substations** under section 120M(1)(c) of the Act:

- 1.1 **Geelong (GL)**, located at Lat -38.13477, Long 144.33741 (as identified at item 16 in Schedule 1 of the Electricity Safety (Bushfire Mitigation Duties) Regulations 2017); and
- 1.2 **Corio (CRO)**, located at Lat -38.07445, Long 144.35898 (as identified at item 42 in Schedule 1 of the Electricity Safety (Bushfire Mitigation Duties) Regulations 2017).

2. CONDITIONS OF EXEMPTION

The exemptions in clauses 1.1 and 1.2 are granted subject to Powercor's continued compliance with the following conditions:

- 2.1 By 30 April 2023, Powercor must establish a new, **complying substation** which Powercor shall ensure is, and remains, a **complying substation** for purposes of sections 120L and 120M of the Act. Powercor shall provide details of the **new complying substation** to the Minister at least 30 days prior to commencing earth-disturbing works to construct of the substation.
- 2.2 By 30 April 2023, Powercor must transfer each **polyphase electric line segment** identified in column 2 of the table below so that the segment's electricity supply originates from the new **complying zone substation** referenced in clause 2.1 of this Order and has the **required capacity**. Alternatively, subject to Energy Safe Victoria's prior approval, Powercor may:
 - 2.2.1 supply electricity to each **polyphase electric line segment** identified in column 2 of the below table from any other **complying substation** for purposes of sections 120L and 120M of the Act, or
 - 2.2.2 replace each **polyphase electric line segment** identified in column 2 of the below table with **covered** or underground electric line.
- 2.3 From the **effective date** of this Order, Powercor must ensure that any **polyphase electric line segment** supplied from the **CRO** or **GL zone substations** not included in the below table which is located, or comes to be located, in a **hazardous bushfire risk area** shall either be **covered**, or placed underground, or have the **required capacity**.
- 2.4 From the **effective date** of this Order, Powercor must ensure that any **polyphase electric line segment** supplied from the **CRO** or **GL zone substations** that is **covered** or underground is not replaced with bare-wire, overhead conductor, unless otherwise previously approved by Energy Safe Victoria.

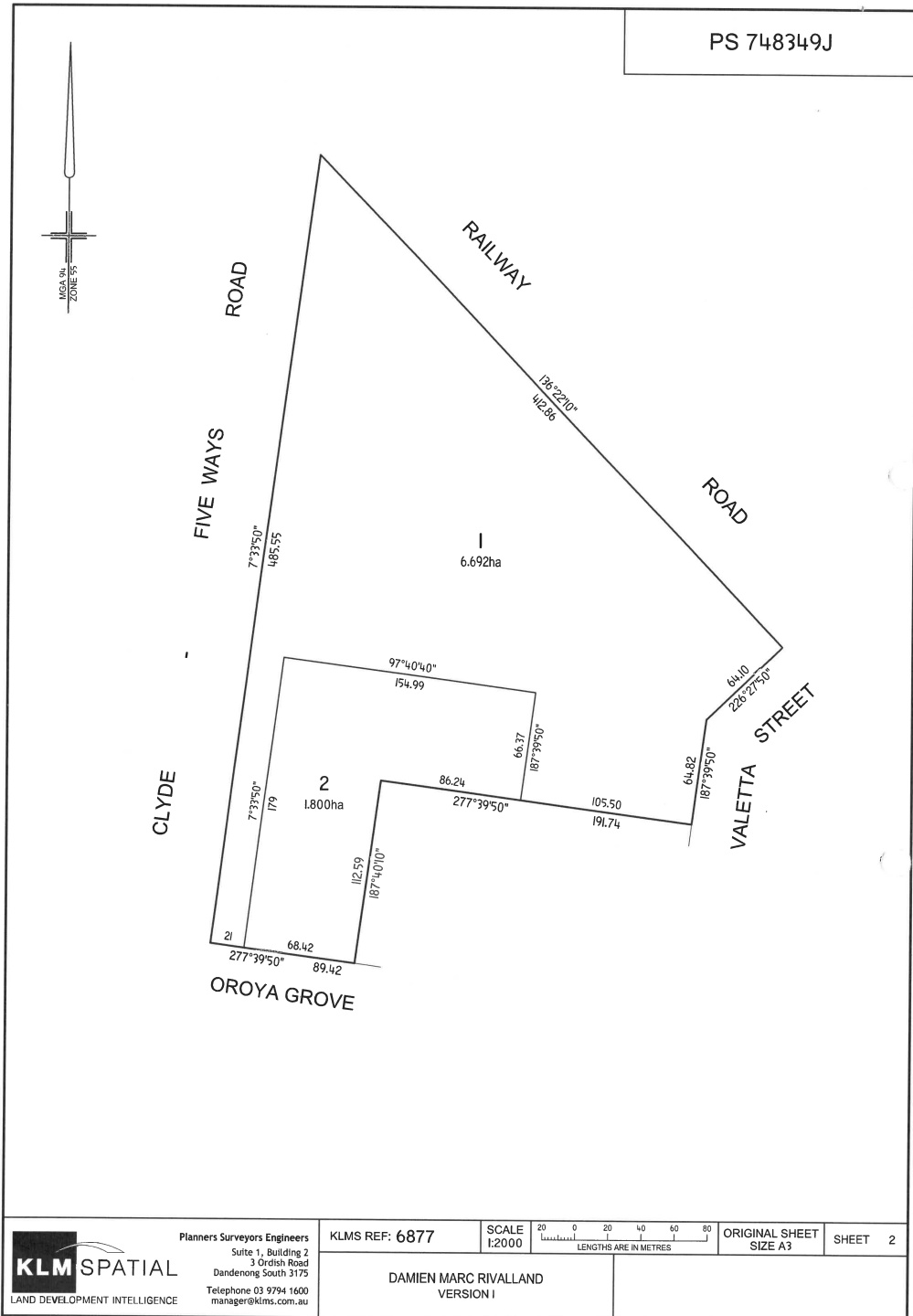

TRANSPORT ACCIDENT CHARGES ORDER (NO. 1) 2020

Order in Council

The Governor-in-Council with the advice of the Executive Council under section 110(8) of the **Transport Accident Act 1986** on the recommendation of the responsible Minister makes the following Order:

This Order will come into effect from 1 July 2020.

1. Title

This Order is called the Transport Accident Charges Order (No. 1) 2020.

2. Commencement

This Order comes into operation on 1 July 2020.

3. Definitions

In this Order –

‘**declared apprentice’s concession**’ means a 50 per cent discount on the TAC charge payable for a vehicle registered under the **Road Safety Act 1986** and classified under category 1(a), 1(b)(i), 2(a) or 2(b) of this Order, in the name of a declared apprentice within the meaning of Regulation 5 of the Road Safety (Vehicles) Regulations 2009.

‘**exempt general-use motorcycle**’ means a general-use motorcycle which –

- (a) at the time when application is made for registration or renewal of registration, application is made by a person who has another general-use motorcycle registered under the **Road Safety Act 1986** that is classified under 3(a)(iii) or 3(a)(iv) of Schedule 1 to this Order, and
- (b) is fitted with an engine with a capacity greater than 125 cc, and
- (c) is the subject of an application for registration or renewal of registration by an individual;

‘**forward-control body-type**’ means a motor vehicle in which the centre of the steering wheel is in the forward quarter of the vehicle’s total length

‘**general-use motorcycle**’ means a motorcycle that is not classified, or to be classified, under 4(b), 4(c), 4(d), 5(b)(ii) or 5(d) of Schedule 1 to this Order;

‘**high risk zone**’ means the parts of the State in which addresses are allocated a postcode listed in Part A of Schedule 2 and, except if the Commission otherwise determines under 110(1A) of the Act, any place outside Victoria;

‘**low risk zone**’ means the parts of the State that are not located in the ‘high risk zone’ or the ‘medium risk zone’;

‘**medium risk zone**’ means the parts of the State in which addresses are allocated a postcode listed in Part B of Schedule 2 to this Order;

‘**pensioner motor vehicle**’ means a motor vehicle that –

- (a) is registered or to be registered in the name of an eligible pensioner within the meaning of the **State Concessions Act 2004**; and
- (b) is eligible to be registered under the **Road Safety Act 1986** in accordance with regulation 102(2) or item 10, 11, 12 or 13 of the Table to Schedule 3 to the Road Safety (Vehicles) Regulations 2009; and
- (c) is registered or about to be registered under the **Road Safety Act 1986**;

‘**prescribed period**’ means the period prescribed for the purposes of section 109 of the Act in relation to a motor vehicle of a certain class specified in regulation 5 of the Transport Accident (Administration of Charges) Regulations 2011;

‘**the Act**’ means the **Transport Accident Act 1986**.

4. Transport accident charge

1. The amount of the transport accident charge applicable to a motor vehicle is the amount shown in Schedule 1 as applicable in respect of –
 - (a) motor vehicles of that class; and
 - (b) the high risk zone, medium risk zone or low risk zone, as the case may be, in which the motor vehicle is usually kept.
2. If the prescribed period in relation to a motor vehicle is less than 3 months the transport accident charge applicable to the motor vehicle in respect of that period is the amount, calculated to the nearest whole dollar, determined in accordance with the formula –
$$\frac{(A \times B)}{365} + \$17$$
where –
 - A is the amount of the transport accident charge applicable under sub-paragraph (1); and
 - B is the number of days in the prescribed period.
3. Despite sub-paragraph (2), if the prescribed period in relation to a motor vehicle is less than 3 months, and is a whole number of months, the transport accident charge applicable to the motor vehicle in respect of that period is the amount, calculated to the nearest whole dollar, determined in accordance with the formula –
$$\frac{(A \times C)}{12} + \$17$$
where –
 - A is the amount of the transport accident charge applicable under sub-paragraph (1); and
 - C is the number of months in the prescribed period.
4. If the prescribed period in relation to a motor vehicle is more than 12 months, the transport accident charge applicable to the motor vehicle in respect of that period is the amount, calculated to the nearest whole dollar, determined in accordance with the formula –
$$\frac{(A \times B)}{365}$$
where –
 - A is the amount of the transport accident charge applicable under sub-paragraph (1); and
 - B is the number of days in the prescribed period.
5. Despite sub-paragraph (4), if the prescribed period in relation to a motor vehicle is more than 12 months and is a whole number of months, the transport accident charge applicable to the motor vehicle in respect of that period is the amount, calculated to the nearest whole dollar, determined in accordance with the formula –
$$\frac{(A \times C)}{12}$$
where –
 - A is the amount of the transport accident charge applicable under sub-paragraph (1); and
 - C is the number of months in the prescribed period.

6. If the motor vehicle is a pensioner motor vehicle the transport accident charge applicable to the motor vehicle is one-half of the transport accident charge that would otherwise be payable.
7. If the motor vehicle is subject to the 'declared apprentice's concession' the transport accident charge applicable to the motor vehicle is one-half of the transport accident charge that would otherwise be payable for motor vehicles classified under classes 1(a), 1(b)(i), 2(a) or 2(b).
