Under subclause 24(1) of the Glen Eira City Council Classified Tree Local Law (Local Law), I am satisfied that it is desirable to make an interim protection order in relation to the Camphor laurel (Cinnamomum camphora) tree (the tree) located at 15–17 Takapuna Street, Caulfield South, Victoria 3162. While the interim protection order remains in force, the tree is included in the Classified Tree Register as a Classified Tree. A person must not without a Permit: (a) remove, damage, kill or destroy or direct, authorise or allow to be removed, damaged, killed or destroyed a Classified Tree; or (b) prune or direct, authorise or allow to be pruned a Classified Tree; or (c) carry out, or direct, authorise or allow to be carried out any Works within the Tree Protection Zone of a Classified Tree.

GENERAL LOCAL LAW 2020

Pursuant to section 119(3) of the **Local Government Act 2020** at its Ordinary Meeting of Council on 15 September 2020, Council passed its new General Local Law 2020. The law will be in effect for 10 years unless otherwise amended.

The objectives of the General Local Law 2020 are to provide for all of the following:

- (1) the peace, order and good government of the municipal district;
- (2) a safe and healthy environment so that the community of the municipal district can enjoy a quality of life that meets its expectations;

- (3) the safe, fair and reasonable use and enjoyment of public places;
- (4) the protection and enhancement of municipal buildings, public assets and Council assets and the amenity and environment of the municipal district;
- (5) the safe, fair and reasonable use and enjoyment of property;
- (6) the uniform and fair administration of this Local Law.

The Local Law provides for the administration, management and protection of amenity and safety throughout the municipal district and repeals the Strathbogie Shire Council Community Local Law No. 6 (2010).

WODONGA CITY COUNCIL

Order Made Under Section 26(2) of the **Domestic Animals Act 1994**

This Order repeals Wodonga City Council Order made under section 26(2) of the **Domestic Animals Act 1994**, on 14 April 2014.

Order for the Control of Dogs

- (1) A person must not bring or permit a dog to be brought into a public place unless the dog is under the person's **effective control**.
- (1A) A dog is not regarded as being under **effective control** unless:
 - (a) the owner is physically able to bring the dog under control by the means of a leash, chain or cord in a public place or other areas as designated; or
 - (b) the dog is tethered to a fixed object and is under the continuous supervision of a person who is physically able to control the dog;
 - (c) the dog is participating in an obedience trial, or training for an obedience trial, under the supervision of an organisation recognised by the local government for the purposes of this section; or
 - (d) the dog is being exhibited at an exhibition under the supervision of an organisation recognised by the local government for the purposes of this section.

- (2) When in a designated off-leash area, an owner must bring their dog under **effective control**:
 - (a) within 10 metres of:
 - i. any playground or children's play equipment,
 - ii. the principal location of an **organised sporting** or community event or festival as determined by council,
 - iii. the principal location of an organised public meeting, or
 - iv. stock in council-owned leased areas, which includes fire trails when stock are being used for fire prevention activities.
 - (b) within 3 metres of:
 - i. a permanent barbecue or picnic area when in use.
 - (c) on other sites including:
 - i. WREN reserves;
 - ii. Gateway Village precinct;
 - iii. public viewing areas at organised sporting events;
 - iv. any area or **organised event** designated by council, e.g. Children's Fair, Chryslers on the Murray Show, Australia Day Events, public concerts, etc.,
 - v. unless otherwise signposted.
- (3) Dogs are prohibited from the following areas at all times:
 - inside all public gated and/or secured playgrounds;
 - within 3 metres of open playgrounds with equipment and soft fall area;
 - on the playing field at any time during a scheduled event/game/match;
 - Wodonga Athletics track;
 - any area designated by council as environmentally sensitive, or
 - any event designated by council as being a pet-free event.
- (4) All dogs must be under **effective control** at all times unless in a designated park or reserve or other designated off-leash gated or ungated dog park where a dog may be exercised off a leash if:
 - a dog/s is accompanied by a competent person in an area declared to be an off-leash area by a declaration under this section (but only if the total number of dogs that the person is accompanied by or has control of, does not exceed 4 dogs;
 - the owner has the dog/s under voice or hand control to sufficiently prevent the dog/s from behaving in a manner which threatens or causes a nuisance to any person or animal;
 - the owner carries a leash, chain, cord or similar not exceeding 1.5 metres in length so as the dog/s can be brought under effective control if it is behaving in a manner which threatens or causes a nuisance to any person or animal; and
 - the owner is within 25 metres and has a clear unobstructed view of the dog/s at all times; and
 - the dog/s immediately returns to its owner upon command.
- (5) This section does not apply to
 - (a) an approved dog belonging to a primary producer or stockman that is engaged in the droving, tending or working stock, or
 - (b) a police dog, or
 - (c) a corrective services dog.

(6) Designated off-leash areas are subject to change as the municipality develops. Accordingly the Wodonga Chief Executive Officer has the power to amend, remove or add new sites and they will be listed in Schedule 1.

In this Order:

Designated Reserve/Park means any reserve determined or posted by council, whether or not delineated by a sign, as set out at Schedule 1.

Effective control means placing a leash, chain, cord or similar not exceeding 1.5 metres in length on a dog and held by the owner.

Organised meeting means a planned community meeting during a nominated period of time, to undertake such an activity under licence, agreement or casual use agreement or Local Laws permit with Council.

Organised sporting event means is a planned training session or competition session or similar where the ground, field, court or similar is required for a nominated period of time to undertake such an activity under a seasonal licence, agreement or casual-use agreement with Council.

Owner has the same meaning as described in the **Domestic Animals Act 1994**.

Public place has the same meaning as described in the Summary Offences Act 1996.

Schedule 1 sets out areas within the municipality which are designated as being off-leash areas, but with dogs under voice control.
