AMENDMENT TO THE GENERAL LOCAL LAW (NO. 1 OF 2015)
MOYNE SHIRE COUNCIL GENERAL (AMENDMENT) LOCAL LAW NO. 3-2019

In accordance with section 119(3) of the **Local Government Act 1989**, notice is hereby given that Moyne Shire Council (Council) has amended the Moyne Shire General Local Law No. 1-2015 (Local Law) by making Moyne Shire Council General (Amendment) Local Law No. 3-2019 (New Local Law).

The objectives of the New Local Law are to:

- revise the Dog Restriction Areas in the map of Port Fairy in Schedule 6 of the Local Law (as referred to in Clause 41.3 of the Local Law), such that the dog restrictions applying to South Beach between Powling Street and the South Beach access steps, and East Beach between Connolly Street and Battery Lane commence on 24 December rather than 1 December each year; and
- include a requirement that dogs must be on-lead within 50 metres of any identified hooded plover nesting site located between Connelly Street and Anna Catherine Drive, Port Fairy.

The effect of the New Local Law delays the commencement of the period when dog restrictions apply to beaches in Port Fairy to more closely align the restriction period with the period of increased visitation and to reduce the impact on shore nesting birds, in particular, hooded plovers.

INTERIM EXEMPTION

Application No. H241/2020

The Victorian Civil and Administrative Tribunal is considering an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Women's Circus Limited (the applicant). The application for exemption is to enable the applicant to:

- employ only women as staff members and engage only women as contractors;
- confine participation in programs, workshops and other activities offered by the applicant to women only; and
- advertise these matters.

(together, the exempt conduct).

At the directions hearing held on 5 November 2020, the applicant applied for an interim exemption to enable the applicant to continue the exempt conduct while the exemption application is considered and concluded.

Upon reading the material filed in support of this application, including the affidavit of Meghan Bourke, the Tribunal is satisfied that it is appropriate to grant an interim exemption from sections 16, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct until the application is finally determined.

In granting this exemption the Tribunal noted:

- The Women's Circus Limited has previously been granted exemptions (A59/2012, A317/2007, A426/2002, A427/2002, A39/2000, A48/1996) with the most recent having expired in May 2017. It may be that no exemption is required because section 12 or an exception applies. At this preliminary stage there is not enough evidence for the Tribunal to be satisfied that this is the case.
- The applicant aims to assist women by providing them with access to a safe and supportive environment to learn and develop skills, build confidence and grow their support networks in a women only environment. The applicant aims to provide women classes, residencies and programs to prepare women to pursue circus performance as a vocation. The applicant's foundational objective is to provide a safe space to support the development and healing of women survivors of sexual assault and domestic violence.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this interim exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of men who would wish to be employed or engaged by the applicant or who would wish to participate in its activities. The Tribunal is satisfied that, in the circumstances discussed above, the limit imposed by this interim exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an interim exemption from the operation of sections 16, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 5 February 2021, or when the substantive application is determined, whichever occurs first.

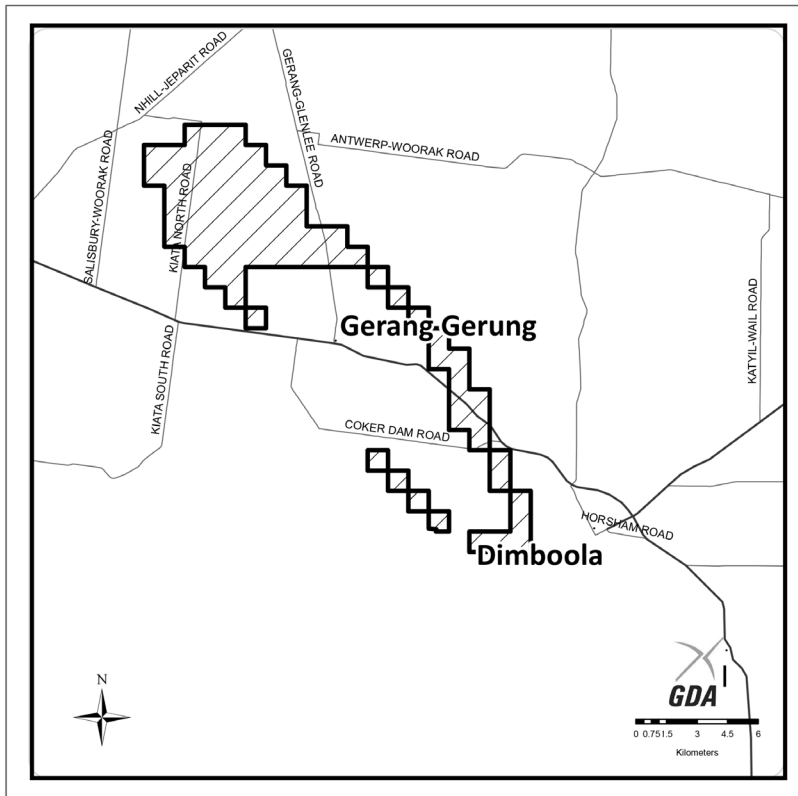

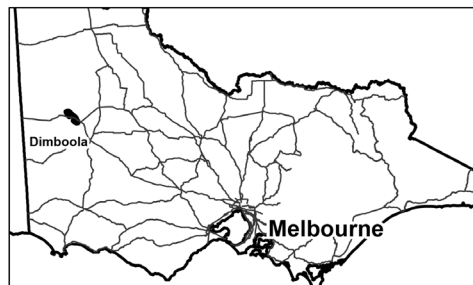
