The Minister for Planning has approved Amendment C367melb to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment extends the expiry date of the interim heritage controls that apply within the Southbank area and West Melbourne until 22 January 2021, corrects a mapping error created through Amendment C304 to the Melbourne Planning Scheme, corrects a clerical error in the schedule to the heritage overlay clause 43.01 and extends the expiry date for Schedule 7 to clause 37.04 Capital City Zone for one year until 22 January 2021.
