## Road Management Act 2004

### DESIGNATION OF TOW-AWAY AREA UNDER SCHEDULE 4 CLAUSE 5

#### Tow-Away Area for 2020 Moomba Parade

Clause 5 of Schedule 4 to the **Road Management Act 2004** provides that a State road authority may move, keep or impound any vehicle that is unlawfully parked or left standing in an area designated by the Minister, (referred to in this instrument as a ‘tow-away area’), and may charge the owner of the vehicle a reasonable fee.

For the purposes of that provision, I, Keith Weegberg, Senior Manager Real Time Management (Roads) of the Department of Transport and delegate of the Minister for Roads, designate the locations specified and shown on the attached plans, to be a tow-away area to facilitate traffic management as part of the 2020 Moomba Parade.

This instrument takes effect at 3.00 pm on 8 March 2020 and expires at 5.00 pm on 9 March 2020.

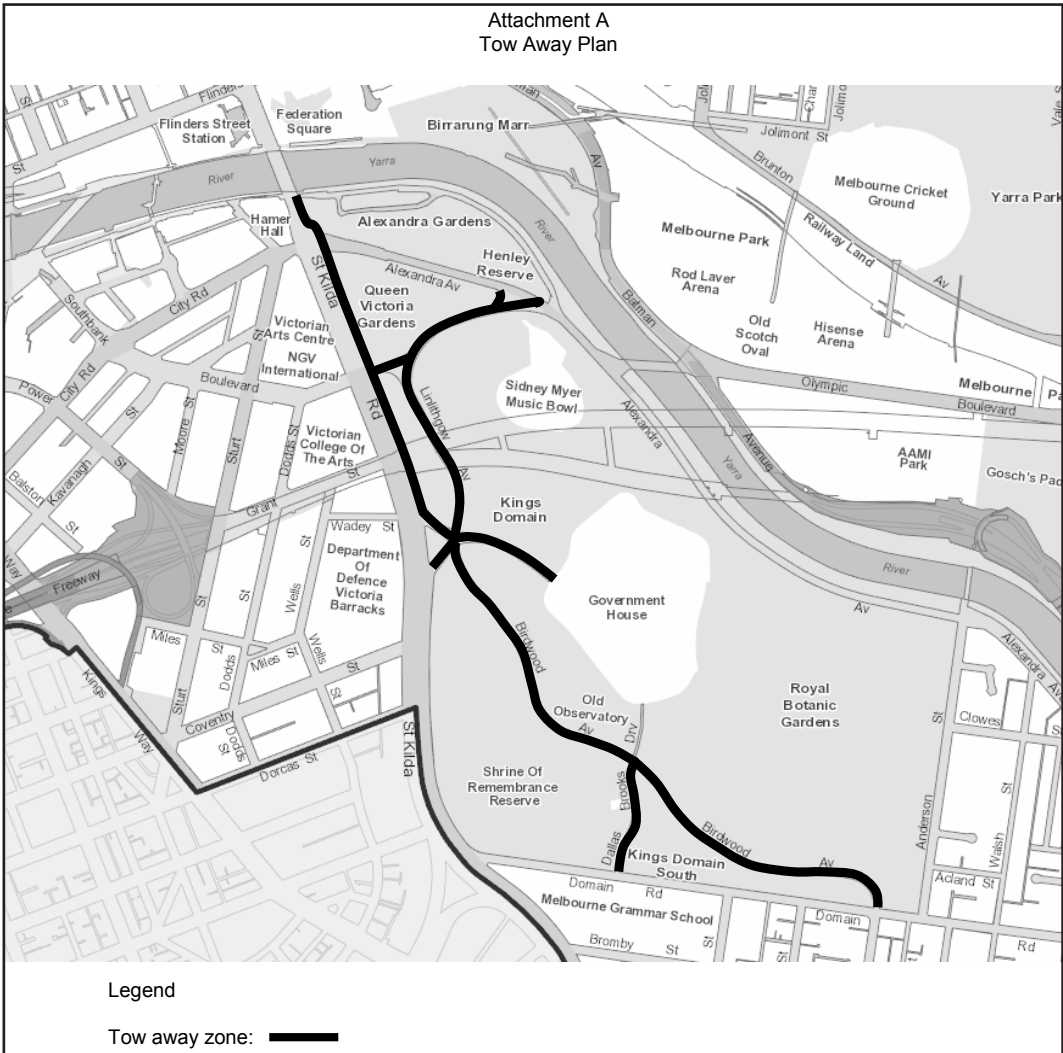
- Anzac Avenue between St Kilda Road and Birdwood Avenue (south side)
- Birdwood Avenue between Dallas Brooks Drive and Anzac Avenue (both sides)
- Birdwood Avenue between Dallas Brooks Drive and Domain Road (both sides)
- Dallas Brooks Drive between Domain Road and Birdwood Avenue (east side)
- Government House Drive between St Kilda Road and Birdwood Avenue (north side)
- Linlithgow Avenue between St Kilda Road and Alexandra Avenue (both sides)
- Linlithgow Avenue between St Kilda Road and Government House Drive (both sides)
- St Kilda Road between Anzac Avenue and Coventry Street (east side)
- St Kilda Road between Grant Street and Wadey Street (east side)
- St Kilda Road between Southbank Boulevard and Grant Street (east side)
- St Kilda Road between Wadey Street and Anzac Avenue (east side)
- St Kilda Road between Yarra River and Southbank Boulevard (east side)
