Melbourne City Link Act 1995

NOTICE OF PARTIAL REVOCATION OF CITY LINK – SOUTHERN LINK SECTIONS 2 AND 4

I, the Hon. Jaala Pulford MP, Minister for Roads and the Minister administering the **Melbourne City Link Act 1995** ('the Act'), in accordance with section 61A(3) of the Act, give notice that I have today made a revocation of part of the City Link Southern Link Sections 2 and 4 declarations pursuant to section 61A(1) of the Act. A copy of that partial revocation is printed with this notice.

On publication of this notice in the Government Gazette, by operation of section 61(4) of the Act, the land which is the subject of the notice will cease to be:

- (a) a freeway or an arterial road within the meaning of the **Road Management Act 2004**; and
- (b) a road open to and for use by the public for passage with vehicles, and all rights, easements and privileges existing or claimed in it as a road will therefore cease; and
- (c) a highway within the meaning of the **Road Safety Act 1986**.

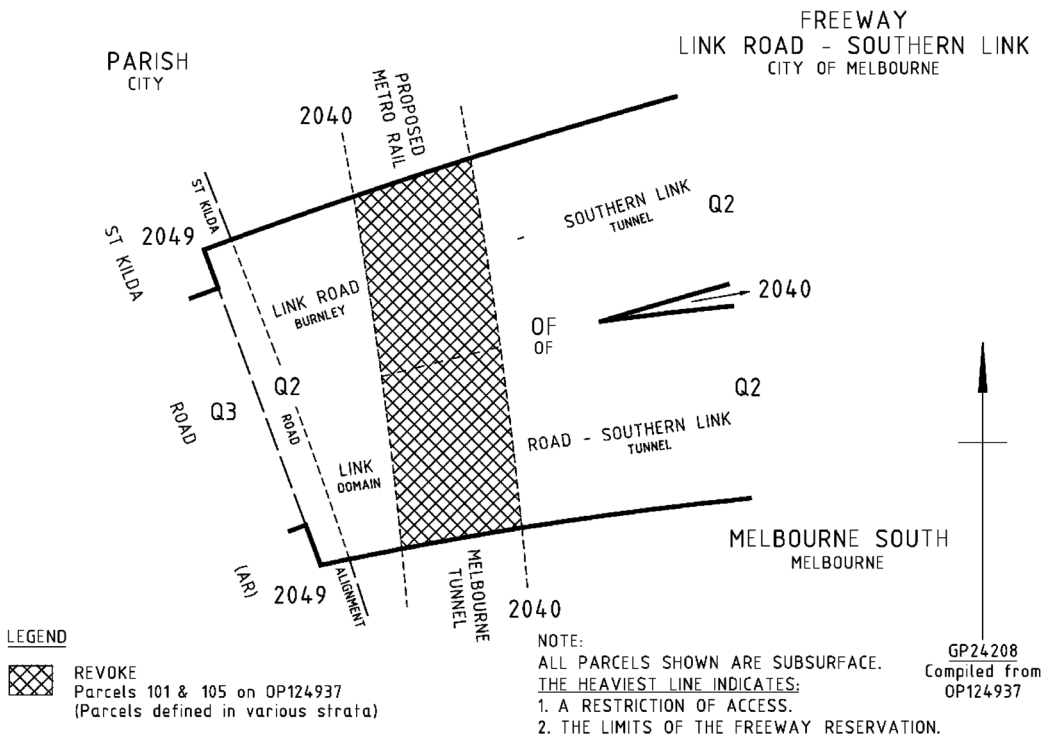
