#### 1 Objectives

The objective of these Regulations is to amend the expiry date of the Crown Land (Reserves) (Yarra Park) Regulations 2010.

#### 2 Authorising Provision

These Regulations are made under section 13 of the **Crown Land (Reserves) Act 1978**.

#### 3 Commencement

These Regulations come into operation on the day on which they are published in the Government Gazette.

#### 4 Principal Regulations

In these Regulations, the Crown Land (Reserves) (Yarra Park) Regulations 2010 which were published in Special Government Gazette No. S 88 on 15 March 2010, pages 1 to 16, and subsequently amended by the Crown Land (Reserves) (Yarra Park) Amendment Regulations 2011 published in Government Gazette No. G 21 on 26 May 2011, page 1148, are called the Principal Regulations.

#### 5 Extension of Expiry Date

For regulation 4 of the Principal Regulations **substitute** –  
'These Regulations expire on 15 March 2021.'
